
**SUBJECT: MESSAGE FROM THE CABINET SECRETARY TO THE NATIONAL TREASURY REGARDING NOMINATION OF A PERSON FOR APPOINTMENT AS THE CHIEF EXECUTIVE OFFICER OF THE NATIONAL GOVERNMENT CONSTITUENCIES DEVELOPMENT FUND BOARD**

**WHEREAS** Standing Order 42(2) and (4) of the National Assembly Standing Orders requires the Speaker to cause the transmission of any Message received from a Cabinet Secretary at a time when the House is not in Session to every Member and later report such Message to the House at its next sitting;

**IT IS HEREBY NOTIFIED** to all Members of the National Assembly that, on Tuesday, March 24, 2020, the Speaker received a Message from the Cabinet Secretary for the National Treasury and Planning asking the House to approve the appointment of **Mr. Yusuf Mbuno** as the Chief Executive Officer of the National Government Constituencies Development Fund (NG-CDF) Board in furtherance to the provisions of section 20 of the National Government Constituencies Development Fund (NG-CDF) Act, 2015 and regulation 4 of the *NG-CDF Regulations, 2016*;

**NOW THEREFORE**, in keeping with the requirements of Standing Order 42(2) and (4)-

- (a)** Upon resumption, I shall convey the message from the Cabinet Secretary to the assembled House so as to cause the commencement of the necessary vetting processes as contemplated under the Public Appointments (Parliamentary Approval) Act, the NG-CDF Act, 2015 and Standing Order 45 (*Committal to Committees*); and,
