**SUBJECT: NOTIFICATION OF NOMINATION OF PERSONS TO

**WHEREAS** Standing Order 42(2) and (4) of the National Assembly Standing Orders requires the Speaker to cause the transmission of any Message received from the National Executive at a time when the House is not in Session to every Member and later report such a Message to the House at its next Sitting;

**WHEREAS** the House, by way of a resolution made on May 6, 2020 requires the Speaker to forthwith refer any Message relating to appointments to a State or public office received during the *May-June recess* to the relevant Committee for consideration, without having to recall the House;


