**THAT**, this House adopts the Report of the Budget and Appropriations Committee on the Budget Estimates for the National Government, the Judiciary and Parliament for the Financial Year 2020/2021, *laid on the Table of the House on Thursday, June 4, 2020*, and pursuant to the provisions of Article 221 of the Constitution of Kenya, section 39 of the Public Finance Management Act, 2012 and Standing Orders 235 and 239, **approves** the issuance of a sum of **Kshs. 1,883,022,058,155** from the Consolidated Fund to meet the expenditure during the year ending 30<sup>th</sup> June 2021 in respect of the Votes as contained in the Schedule to the Order Paper.
