080/2020 The Member for Lamu County (Hon. Ruweida Obo, MP) to ask the Cabinet Secretary for Water, Sanitation and Irrigation: -

- (i) Could the Cabinet Secretary explain why MangaiKiunga Water Project allocated Kshs. 40million from the Equalization Fund was relocated from Basuba Ward in Lamu County thus denying the much needed water for the disadvantaged Community in the said Ward?
- (ii) What measures is the Ministry putting in place to provide water to the Communities of *Basuba* Ward and *Hindi* Ward and in particular *Mokowe* Town in Lamu County?
