1.0 PREFACE

On behalf of the Departmental Committee on Transport, Public Works and Housing and pursuant to provisions of Standing Order 199 (6), it is my pleasant privilege and honour to present to this House the Report on the Petition on Inclusion of project costs on the project sign board for all public funded project.

The petition was tabled before the House pursuant to Standing Order 225 (2) (b) by Mr. Boniface Mwai Gachunga of ID no. 22377410

Pursuant to Standing Order 227 (1), the petition was referred to the Departmental Committee on Transport, Public Works and Housing for consideration and preparation of a report within 60 days.

1.1 Mandate of the Committee and Membership

a) Mandate

- 1. The Departmental Committee on Transport, Public Works and Housing is established under Standing Order 216(1) whose mandate, pursuant to the Standing Order 216 (5), is as follows;

 - k. examine any questions raised by Members on a matter within its mandate.

1.4 Committal and Consideration of the Petition

- 5. Pursuant to the provisions of Standing Orders 227 (1), the petition was referred to the Departmental Committee on Transport, Public Works and Housing for consideration and preparation of a report within 60 days. The Committee proceeded with the consideration of the petition by holding meetings to set up terms of reference and scheduling meetings.
- 6. In considering the petition, the Committee invited and held meetings with the officials from the State Department for Public Works, The National Construction Authority as well as the Petitioner, Mr. Boniface Mwai Gachunga. The meetings were aimed at responding to issues raised by the petitioner.

1.5 Committee Observations

- 7. Having held meetings and considered the submissions presented on the petitions, the Committee observed that the petitioners had prayed that the National Assembly through the Committee on Transport, Public Works and Housing:
 - i. considers and amend the NCA act and any other applicable laws to make it a statutory requirement for the total cost of a public-funded project to be **included and displayed** in the project sign-board; and that
 - ii. in his humble opinion, this will go a long way into capturing the aspirations and the spirit of the provisions of article 10 of the constitution of Kenya 2010.

In response to the above prayers, the Committee recommends that: -

8. The Committee observed that it may have to request for views from the Public Procurement Regulatory Authority (PPRA) before making its determination because the issue of costing and accountability may be beyond the scope of the National Construction Authority. The Committee however was of the opinion that procurement laws are more comprehensive in terms of ensuring accountability and thus there is no need to amend the NCA Act.

2.0 BACKGROUND INFORMATION

- 9. The Petition on proposal to amend the National Construction Authority Act to provide for inclusion of the Cost of Public Funded Projects on Project Sign Boards was conveyed to the House by the Hon. Speaker of the National Assembly on 28th September, 2021 pursuant to Standing Order 225 (2)(b).
- 10. Pursuant to House rules, the petition was referred to the Departmental Committee on Transport, Public Works and Housing for consideration and preparation of a report within 60 days. The Committee considered the petition pursuant to the provisions of Standing Order 227.

The petitioners wished to draw the attention of the National Assembly to the following: -

- i. **THAT**: Article 10 of the constitution of Kenya requires all stage organs, state officers, public officers and all persons whenever any of them:
 - 1.1 Applies or interprets the constitution
 - 1.2 Enacts, applies and interprets any law or
 - 1.3 Makes or implements public policy

To strictly observe and be guided by our national values and principles always in the course of executing their mandate.

- ii. THAT the National Construction Authority Regulations (2014) enumerate the items to be included in the project sign board but conspicuously missing in the list of requirements is the PROJECT COST FORPUBLIC FUNDED PROJECTS.
- iii. **THAT,** I have made the best efforts to have this matter addressed by the relevant authorities- in this case National Construction Authority which have failed to give a satisfactory response.
- iv. **THAT,** none of this issue raised in the petition is pending in any court of law, constitutional or any other legal body.

THEREFORE, your humble petitioner prays that the National Assembly –

- v. considers and amend the NCA act and any other applicable laws to make it a statutory requirement for the total cost of a public-funded projects to be **included and displayed** in the project sign-board
- vi. That this in his humble opinion will go a long way into capturing the aspirations and the spirit of the provisions of article 10 of the constitution of Kenya 2010.

3.0 SUBMISSIONS AND EVIDENCE

11. Having been seized of the Petition, the Committee commenced its consideration by inviting Mr. Boniface Mwai and the officials from the State Department for Public Works as well as officials from the National Construction Authority. During the meeting, written and oral evidence was adduced as recorded hereunder.

3.1 SUBMISSION FROM THE PETITIONER

12. The Petitioner, Mr. Boniface Mwai, took Member through the petition. He explained that disclosure of cost is an important aspect both from an accounting perspective and it terms of good governance. He explained that whereas the information on cost is not a secret, he was praying that the National Assembly makes it easier to access, thereby the need for the amendment to the law to provide for the same on sign boards.

3.2 SUBMISSION FROM THE NATIONAL CONSTRUCTION AUTHORITY

13. In his presentation to the Committee, The National Construction Authority, through the Principal Secretary for Public Works and the Executive Director NCA, submitted that the costs are available in all government agency websites in line with a Presidential Directive issued some years ago. They further submitted that including the cost of projects in sign boards may enhance the use of the board to include accountability for resources. However, for the board to be used for this purpose, there may be need to add other information as accountability may not be judged by cost alone. They submitted that the cost is not included in the board because the guidelines are mainly intended to enhance quality assurance and to confirm compliance.

The NCA Act No. 41of 2011does not have any express provision under the Act that requires a developer whether public or private to have a site sign Board. This is a requirement under the Physical Land Use and Planning Act.

The site sign Board is a requirement at the point of approval of the project by the respective county. In furtherance of section 5(1) (n), of the NCA Act, the National Construction Authority has developed guidelines for a standard Construction Site Sign Board for projects being undertaken by private developers, Ministries, Departments and Agencies to capture standard details for display. However, the cost of the project is not included.

As per the guidelines, the project site sign board is required to have the following information on it;

- A. Project- Name of location (Land no.) to be constructed;
- B. Ownership details-client/developer
- C. Supervising consultants namely;
 - i. Architect
 - ii. Electrical engineer
 - iii. Quantity surveyor
 - iv. Civil/ structural engineer
 - v. Mechanical engineer
 - vi. Other (consultants involved in the project not outlined in 3
- D. Contractor
 - i. Main contractor
 - ii. Subcontractor(s)
- E. Statutory approvals
 - i. County construction permit as per PLUPA2019;
 - ii. NEMA license
 - iii. NCA Compliance certificate
 - iv. Others (approval for the project not outlined in 5)

As regards the cost, it is disclosed in the certificate of compliance issued to the applicant.

Including the cost may enhance the use of the board to include accountability for resources. However, for the board to be used for this purpose, there may be need to add other information as accountability may not be judged by cost alone.

The cost is not included in the board because the guidelines are mainly intended to enhance quality assurance and to confirm compliance

4 COMMITTEE OBSERVATIONS AND RECOMMENDATION

4.1 OBSERVATIONS

14. The Committee observed that it may request the Public Procurement Regulatory Authority (PPRA) to provide any additional information on the issues raised in the Petition because the issue of costing and accountability may be beyond the scope of the National Construction Authority.

4.2 **RECOMMENDATIONS**

15. The Committee having heard from the officials makes the following recommendation, that: - The Committee was satisfied with the Ministry's response and was of the opinion that procurement laws are more comprehensive in ensuring accountability and thus there is no need to amend the NCA Act.

CONVEYANCE OF A PUBLIC PETITION

(No. 044 of 2021)

REGARDING A PROPOSAL TO AMEND THE NATIONAL CONSTRUCTION AUTHORITY ACT TO PROVIDE FOR INCLUSION OF THE COST OF PUBLIC FUNDED PROJECTS ON PROJECT SIGN BOARDS

Honourable Members, Standing Order 225(2) (b) requires the Speaker to report to the House any petition, other than those presented by a Member. Further, Article 119 of the Constitution provides for the right of any person to petition Parliament to consider any matter within its authority, including petitioning the House to enact, amend or repeal any legislation.

In this regard, **Honourable Members**, I wish to report to the House that my office has received a petition signed by Mr. Boniface Mwai Gachunga of ID No. 22377410. The Petitioner states that both the National Construction Authority Act, 2011 and the National Construction Authority Regulations, 2014 do not include the requirement that the cost of all public funded projects be included in the list of items displayed on project sign boards. He claims that the above omission negates the constitutional principle of good governance, integrity, transparency and accountability as envisaged under Article 10(2)(c) of the Constitution.

Honourable Members, the Petitioner therefore prays that the National Assembly amends the relevant provisions of the National Construction Authority Act, 2011 with a view to entrenching in law a mandatory

requirement to that the full cost of all public funded projects be displayed on project sign boards.

Honourable Members, having determined that the matters raised by the Petitioner are well within the authority of this House, I order that, pursuant to the provisions of Standing Order 227(1), this petition be committed to the Departmental Committee on Transport, Public Works and Housing. The Committee is required to consider the Petition and report its findings to the House and to the Petitioner in accordance with Standing Order 227(2).

 - e. investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
 - f. to vet and report on all appointments where the Constitution or any law requires the National Assembly to approve, except those under Standing Order 204 (Committee on Appointments);
 - g. examine treaties, agreements and conventions;
 - h. make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
 - i. make reports and recommendations to the House as often as possible, including recommendation of proposed legislation;
 - j. consider reports of Commissions and Independent Offices submitted to the House pursuant to the provisions of Article 254 of the Constitution; and
 - k. examine any questions raised by Members on a matter within its mandate.

- 2. Further, the Second Schedule to the Standing Orders mandates the Committee to consider matters relating to the following subjects:

1.2 Committal and Consideration of the Petition

- 6. Pursuant to the provisions of Standing Orders 227 (1), the petition was referred to the Departmental Committee on Transport, Public Works and Housing for consideration and preparation of a report within 60 days.
- 7. The Committee proceeded with the consideration of the petition by holding meetings to set up terms of reference and schedule meetings.
- 8. In considering the petition, the Committee invited and held meetings with the officials from the Ministry of Transport and Infrastructure, The National Treasury, the Kenya Railways and the Hon. David Ole Sankok, M.P, on behalf of the Petitioners. The meetings were aimed at responding to issues raised by the petitioners.

1.3 Committee Observations

9. Having held meetings and considered the submissions presented on the petitions, the Committee observed that: -

1.4 Prayers in the Petition

- 10. The petitioners had prayed that the National Assembly through the Committee on Transport, Public Works and Housing: -
 - (i) Inquiries into the circumstances under which the SGR Phase 2B Project has terminated in a remote Emurutoto Shopping Center instead of Narok Town;
 - (ii) Intervenes through the relevant Government Ministries to ensure that the 12km stretch from Emurutoto Shopping Center to Narok Town, which has sufficient human traffic and adequate economic viability and that a link to the highly productive Greater Lake Region be constructed;
 - (iii) Recommends to the Ministry of Transport and Infrastructure and the National Treasury to identify financial resources to complete the 12km stretch of SGR to Narok Town, and to urgently ensure that the already constructed 52km stretch is safeguarded from vandalism perpetrated by scrap metal dealers and that it does not fall into utter disuse; and
 - (iv) Makes appropriate recommendations with respect to ensuring the short and mediumterm viability of Phase 2B of the SGR is realized.

In response to the above prayers, the Committee recommends that: -

- 1. The National Treasury and the Kenya Railways Corporation undertakes costing for SGR project completion from Emurutoto to Narok Town.
- 2. The National Treasury and the Kenya Railways Corporation prioritizes the allocation of funding for the remaining part of the project from Emurutoto to Narok Town.
- 3. The National Treasury considers including the allocations in the Estimates for the Financial Year 2022/2023.

THEREFORE, the petitioners prayed that the National Assembly through the Departmental Committee on Transport, Public Works and Housing: -

- (i) Inquiries into the circumstances under which the SGR Phase 2B Project has terminated in a remote Emurutoto Shopping Center instead of Narok Town;
- (ii) Intervenes through the relevant Government Ministries to ensure that the 12km stretch from Emurutoto Shopping Center to Narok Town, which has sufficient human traffic and adequate economic viability and that a link to the highly productive Greater Lake Region be constructed;
- (iii) Recommends to the Ministry of Transport and Infrastructure and the National Treasury to identify financial resources to complete the 12km stretch of SGR to Narok Town, and to urgently ensure that the already constructed 52km stretch is safeguarded from vandalism perpetrated by scrap metal dealers and that it does not fall into utter disuse; and
- (iv) Makes appropriate recommendations with respect to ensuring the short and medium-term viability of Phase 2B of the SGR is realized.

3.0 SUBMISSIONS AND EVIDENCE

14. Having been seized of the Petition, the Committee commenced its consideration by inviting the Hon. David Ole Sankok, MP and the officials from the Ministry of Transport and Infrastructure, the Kenya Railways and the National Treasury. During the meetings, written and oral evidence was adduced as recorded hereunder.

3.1 Submission from the Petitioner

- 15. The petitioner, Hon. David ole Sankok, MP appeared before the Committee and explained that the construction of the multibillion 52km Phase 2B SGR line from the Suswa dry port had stalled at Emurutoto Shopping Center, a very remote area with no roads and essential social amenities. He explained that the phase 2B SGR project could be more viable if the 12km stretch to Narok Town was completed to give it an economic catchment area of the Greater Lake Region.
- 16. The petitioner explained that he was not convinced with the explanation by the Principal Secretary for Transport who, in the same meeting, explained that the project ended abruptly because of lack of funds. The petitioner explained that the same Ministry constructed another 30km stretch from the dry port to Longonot even when it ironically maintained it had no funds for the 12km from Emurutoto to Narok.

3.2 Submission from the State Department for Transport

17. In his presentation to the Committee, the Principal Secretary for Transport submitted that the project ended abruptly because of lack of funds but that the Ministry was looking for a way out. The Petitioner however contested that assertion.

- 18. The Committee asked the Principal Secretary for Transport to bring a report in two weeks on the following:
 - a) Estimated cost of building the remaining 12km stretch from Emurutoto to Narok Town;
 - b) A report on the scope of the phase 2B SGR project contract; and
 - c) Possibility of using the RDLF to fund the 12km stretch
- 19. The Committee, after a long wait, observed that the report was not forthcoming from the State Department for Transport. Subsequently, the Committee noted *suo moto* that the affairs of Kenya Railways were vested in the National Treasury pursuant to Executive Order Number 5 of 2020. It was then that the Committee resolved to invite the National Treasury for a meeting on the same.

3.3 Submission from the Kenya Railways Corporation

20. In his presentation to the Committee, the Managing Director for Kenya Railways reinforced the positions provided by the State Department for Transport and the National Treasury, explaining that the main issue was lack of funding. He further submitted that currently, Kenya Railways can only deal with passenger traffic since the 12km stretch was for the time being not commercially very viable.

3.4 Submission from The National Treasury

- 21. In his presentation to the Committee, the Principal Secretary for the National Treasury submitted that the Phase 2B from Naivasha to Kisumu could cost around 3.7 billion shillings. Considering the financial constraints, there was need to temporarily stop at Naivasha. However, the situation was constantly being reviewed and once funds were available, the stretch will be done as well. It was reported that the Naivasha to Longonot route transports cargo but not for the Narok route. The Ministry explained that they were concentrating on the line from Mombasa to Uganda.
- 22. The petitioner, Hon. Sankok, MP however disputed the assertions by the National Treasury explaining that it was more costly to leave the line vandalized at Emurutoto than to build the 12km stretch to Narok Town. He explained that there were enough livestock products to be transported from Narok, as well as other farm products such as potatoes, wheat and among others.
- 23. The Principal Secretary in the National Treasury explained that there was need to maximize use of resources recognizing the constrained fiscal space and keeping in mind the effects of Covid19 pandemic on the economy. He affirmed that the government was however continually reviewing what was in the best interest of the country and the regions.
- 24. The PS explained that currently, it was not possible to complete the 12km stretch in the near future because it was not in the recently approved budget. He submitted that the Ministry will however review and see if in the medium term, it was possible to be done.

2.0 BACKGROUND INFORMATION

- 11. The Petition Regarding the Viability of the Standard Gauge Railway Project was presented to the House by the Hon. David Ole Sankok on 15th July 2020, pursuant to Standing Order 225 (2)(a), on Behalf of The Residents of South Rift and Nyanza.
- 12. Pursuant to House rules, the petition was referred to the Departmental Committee on Transport, Public Works and Housing for consideration and preparation of a report. The Committee considered the petition pursuant to the provisions of Standing Order 227.
- 13. The petitioners wished to draw the attention of the Honorable House to the following: -
 - I. THAT, the design for infrastructure development, particularly road and railway transport, ought to be intended to open up areas it traverses or terminates for economic exploitation and spur economic development;
 - II. **THAT,** having completed Phase 2A of the Standard Gauge Railway (SGR) from Nairobi to Suswa, the Government embarked on design and construction of the westbound Phase 2B of the SGR project from the Suswa Dry Port;
 - III. THAT, residents of South Rift and Nyanza welcomed the project with optimism that it would further open up the regions for economic exploitation, spur economic development and contribute to expansion of urban areas along the SGR line;
 - IV. THAT, unfortunately, the multibillion 52km Phase 2B SGR line from the Suswa Dry Port stalled at Emurutoto Shopping Center, a small shopping centre with only one shop and butchery, neither roads nor any essential social amenities;
 - V. THAT, residents are concerned that there seems to be no indication construction of the Phase 2B of the SGR line will extend to Western Kenya as envisaged;
 - VI. THAT, Phase 2B SGR project could be economically viable if the 12km stretch to Narok Town is completed to give it an economic catchment area of the Greater Lake Region;
 - VII. THAT, residents are further concerned that unless the remaining short stretch of 12km from Emurutoto to Narok Town is completed, the project runs the risk of becoming a white elephant in which billions of shillings sourced through in loans and tax payers' money with little economic returns and benefits to South Rift and Greater Western regions;
 - VIII. THAT, the completion of the 12km stretch to Narok Town could transform and serve as a Special Economic Zone and a hub for residents of the region producing fish, wheat, maize, barley, tea, potatoes, livestock products, bananas, avocados, pineapple, soap stones, sugarcane among other products;
 - IX. THAT, the matters raised in this petition are not pending before any court of law, constitutional or other legal body;

4.0 COMMITTEE OBSERVATIONS AND RECOMMENDATION

4.1 Observations

25. There is need to complete/connect the Emurutoto section to Narok Town with the SGR line, a distance of 12km. This will accelerate economic activities in the larger Narok County and the regions beyond. The Committee however noted that indeed, the country is operating under constrained budgetary provisions, and that the National Treasury has to constantly review the fiscal situation while prioritizing on important development projects.

4.2 Recommendations

The Committee having heard from the officials makes the following recommendation, that: -

- 26. The National Treasury and the Kenya Railways Corporation undertakes costing for SGR project completion from Emurutoto to Narok Town.

However, the situation was constantly being reviewed and once funds were available, the stretch will be done as well. It was reported that the Naivasha to Longonot route transports cargo but not for the Narok route. The Ministry explained that they were concentrating on the line from Mombasa to Uganda.

The petitioner, Hon. Sankok, however disputed the assertions by the Ministry explaining that it was more costly to leave the line vandalized at Emurutoto than to build the 12km stretch to Narok Town. He explained that there were enough livestock products to be transported from Narok, as well as other farm products such as potatoes, wheat and even charcoal.

The Principal Secretary in the National Treasury explained that there was need to maximize use of resources recognizing the constrained fiscal space and keeping in mind the effects of Covid19 pandemic. He affirmed that the government was however continually reviewing what is in the best interest of the country and the regions. He explained that currently it was, it was not possible to complete the 12km stretch because it was not in the recently approved budget. He submitted that the Ministry will however review and see if in the medium term, it was possible to be done.

Way Forward

The Committee proposed that the Principal Secretary for Treasury and the Committee conduct a field visit to the area at the end of August 2021 to assess the area before scheduling another meeting to make a determination.

STATEMENT BY PRINCIPAL SECRETARY TO THE DEPARTMENTAL COMMITEE ON TRANSPORT, PUBLIC WORKS AND HOUSING ON PETITION REGARDING THE ECONOMIC VIABILITY OF PHASE 2B OF THE STANDARD GAUGE RAILWAY (SGR) PROJECT

Mr. Chairman,

I beg to respond to the question on petition regarding the economic viability of Phase 2B of the Standard Gauge Railway (SGR) Project.

Mr. Chairman,

I beg to respond as follows:

Feasibility study for the 262km Naivasha - Kisumu Standard Gauge Railway (Phase 2B SGR) section was prepared in 2016. The scope also included construction of the new Kisumu Port on Lake Victoria, complete with a 9km SGR branch line to serve the new Kisumu Port.

From the feasibility study, it was envisaged that Narok station and its environ would attract significant traffic volumes. It was predicted that in the initial stage, short term and long term, the incoming freight volumes at this station would be 60,000 tons, 90,000 tons and 130,000 tons respectively, mainly consisting of residents' production and living supplies like construction materials and grains. The outgoing freight volumes would be 60,000 tons, 80,000 tons and 110,000 tons respectively mainly consisting of local agricultural products.

Following the construction of SGR Phase 2A, which terminates at Emurutoto, certain pertinent parameters have changed and also this necessitated review of the route for the Phase 2B SGR. In particular,

- (i) 120 KM SGR phase 2A takes off from Nairobi Terminus and terminates at Emurutoto. Hence, SGR Phase 2B, which is yet to commence as funds are still being sourced, will begin from Emurutoto to Kisumu;
- (ii) The 12 km stretch from Emurutoto to Narok is part of proposed SGR Phase 2 B. However, in the short term, Kenya Railway is currently constructing MGR link from Naivasha Dry port to Longonot station to enhance seamless movement of freight from Mombasa port to Malaba; and

(iii) Implementation of Phase 2B SGR will extend the constructed SGR within the Republic of Kenya by a further 262km, bringing the completed length to 854km.

Mr Chairman,

The construction of the Phase 2B is justified on the following grounds:

- (i) Its construction will provide employment, as well as services provision opportunities; thereby spur economic growth along the southern route, where it will traverse;
- (ii) Its operational phase is expected to contribute to an annual growth of 1.5% of the Gross Domestic Product (GDP);
- (iii) The 35 locomotives (i.e 29 locomotives for mainline, 4 locomotives for passenger services and 2 locomotives for shunting), 724 wagons and 64 passenger coaches and other operational equipment to be procured under Phase 2B SGR, will be used in the operations of the completed Mombasa to Naivasha SGR section, thereby relieve constraints on the Mombasa Nairobi SGR locomotives, rolling stock and equipment fleet and enhancing capacity to transport more freight on the SGR network;
- (iv) The existing road network connecting Nairobi through Kisumu to Busia (Kenya/Uganda Border), and through Eldoret to Malaba (Kenya/Uganda Border), suffers congestion due to high traffic volume, and has high maintenance costs due to damage from loaded trucks. Implementation of Phase 2B SGR will alleviate these, and enhance transport along the East African region's Northern Corridor route;
- (v) The existing Kisumu Port has been revamped, Phase 2B SGR will revive inland water transport, through feeding the existing Kisumu Port with transit freight to neighboring countries of Tanzania, Uganda, Rwanda, Burundi and Democratic Republic of Congo (DRC);
- (vi) It will reduce cost of transportation, making the region attractive for investment by improving connectivity with the neighbouring land locked countries;
- (vii) Construction of the SGR Phase 2B and New Kisumu Port will promote development of the Kisumu Industrial Park.

Mr. Chairman,

The viability analysis takes into consideration the projection of the freight beyond Nairobi which also includes the cargo generated from within Nairobi and surrounding area for consumption in the western part of the countries in addition to cargo from potential industrial park to be established in Kisumu. With the projections which are estimated with growth rate of 5% p.a and 6.0% p.a for imports and exports

respectively including cargo generated from Kisumu Industrial Park, the oil products, and the neighbouring countries around Lake Victoria, imports and exports volumes for the Phase Two are as shown in the tables below:

With the above assumptions, the projected cashflow for Phase 2B is as shown in table 3 below given Construction Period will from 2022 to 2025 while in table 4, it is shown that the project is profitable with a net present value of US\$ 3.9 billion with financial internal rate of return of 8.59% and it will take about 15 years to recover the cost as shown below.



REGARDING THE ECONOMIC VIABILITY OF PHASE 2B OF THE STANDARD GAUGE RAILWAY (SGR) PROJECT

- I, the UNDERSIGNED, on behalf of concerned Kenyans especially residents of South Rift and Nyanza, draw the attention of the House to the following;
- 1) THAT, the design for infrastructure development, particularly road and railway transport, ought to be intended to open up the areas it traverses or terminates for economic exploitation and spur economic development;
- 2) THAT; having completed Phase 2A of the Standard Gauge Railway (SGR) from Nairobi to Suswa, the Government embarked on design and construction of the westbound Phase 2B of the SGR project from the Suswa dry Port;
- 3) THAT, residents of South Rift and Nyanza welcomed the project with optimism that it would further open up the regions for economic exploitation, spur economic development and contribute to expansion of urban areas along the SGR line;
- 4) THAT, unfortunately, the multibillion 52km Phase 2B SGR line from the Suswa dry Port stalled at Emurutoto Shopping Center, a small shopping center with only one shop and a butchery, neither roads nor any essential social amenities;
- 5) THAT, residents are concerned that there seems to be no indication construction of the Phase 2B of the SGR line will extend to Western Kenya as envisaged;
- 6) THAT, Phase 2B SGR project could be economically viable if the 12km stretch to Narok Town is completed to give it an economic catchment area of the Greater Lake Region;
- 7) THAT, residents are further concerned that unless the remaining short stretch of 12km from Emurutoto to Narok Town is completed the project runs the risk of becoming a white elephant in which billions of shillings sourced through in loans and tax payers money with little economic returns and benefits to couth Diff and Creater Western and benefits to couth Diff and Creater Western and benefits to couth Diff and Creater Western and the content of the court of the cour

- 8) THAT, the completion of the 12km stretch to Narok Town could transform serve as a Special Economic Zone and a hub for residents of the region producing fish, wheat, maize, barley, tea, potatoes, livestock products, bananas, avocados, pineapple, soap stones, sugarcane among other products;
- 9) THAT, the matters raised in this Petition are not pending in any Court of Law, constitutional or other legal body;

THEREFORE, your humble Petitioners pray that the National Assembly through the Departmental Committee on Transport, Public Works and Housing: -

- Inquires into the circumstances under which the SGR Phase 2B Project (i) has terminated in a remote Emurutoto Shopping Center instead of Narok Town;
- (ii) Intervenes through the relevant Government Ministries to ensure that the 12km stretch from Emurutoto Shopping Center to Narok Town, which has sufficient human traffic and adequate economic viability and that a link to the highly productive Greater Lake Region be constructed;
- (iii) Recommends to the Ministry of Transport and Infrastructure and the National Treasury to identify financial resources to complete the 12km stretch of SGR to Narok Town, and to urgently ensure that the already constructed 52km stretch is safeguarded from vandalism perpetrated by scrap metal dealers and that it does not fall into utter disuse; and
- (iv) Makes appropriate recommendations with respect to ensuring the short- and medium-term viability of Phase 2B of the SGR is realized.
