- 1. The Senate assembled at thirty minutes past Two O'clock.
- 2. The proceedings were opened with Prayer said by the Speaker.

3. QUORUM OF THE SENATE

The Speaker, having counted the Honourable Senators present at the commencement of the Sitting and confirming that there was no Quorum, directed that the Bell be rung for ten minutes, pursuant to Standing Order 40;

And there being a Quorum before the expiry of the ten minutes;

The Speaker invited the Clerk to call out the Orders of the day.

4. COMMUNICATIONS FROM THE CHAIR

The Speaker conveyed the following Communications from the Chair -

i.) On the withdrawal of Published Senate Bills

"Honourable Senators,

As you may recall, on Tuesday, 5th March, 2024, I communicated that following the adoption of the Report of the National Dialogue Committee by the Senate on 21st February, 2024, the following legislative proposals recommended in the Report be introduced in the Senate: -

- i. The Elections Offences (Amendment) Bill, 2024;
- ii. The Elections (Amendment) Bill, 2024;
- iii. The Statutory Instruments (Amendment) Bill, 2024; and
- iv. The Political Parties (Amendment) Bill, 2024.

Given the importance of these Bills emanating from a Bipartisan process, the Senate Majority Leader and the Senate Minority Leader agreed to co-sponsor the Bills. The Bills were subsequently published on 7th March, 2024 and read a first time in the Senate on 20th March, 2024.

The Bills having been read a First Time were committed to the Standing Committee on Justice, Legal Affairs and Human Rights. In line with the requirements of Standing Order 145, the Committee published in two (2) newspapers of national circulation an advertisement on Friday, 19th April, 2024, calling for Submission of Memoranda on the said Bills, with the deadline for submission of the Memoranda being scheduled for Friday, 3rd May, 2024.

Honourable Senators,

On 22nd April, 2024, I received a letter from the Senate Minority Leader, Reference No. *SEN/MLS/SOS/2024/005* expressing concern as to the content of the following Bills as published;

- i. The Elections Offences (Amendment) Bill (Senate Bills No.9 of 2024);
- ii. The Elections (Amendment) Bill (Senate Bills No. 11 of 2024); and
- iii. The Political Parties (Amendment) Bill (Senate Bills No. 13 of 2024).

Given the gravity of this matter, the Senate Business Committee at its meeting held on Tuesday, 30th April, 2024 deliberated on the matter and resolved that corrective measures be taken as a matter of urgency in line with what had been agreed upon in the Report of the National Dialogue Committee.

Honourable Senators,

This being the case, I direct that further consideration of the three (3) aforementioned Bills be ceased in order to facilitate the corrective measures. For avoidance of doubt, the Standing Committee on Justice, Legal Affairs and Human Rights is directed to stop any form of Public Participation and the on-going receipt of Memoranda.

In this respect, I direct the Office of the Clerk to liaise with the Senate Majority Leader and the Senate Minority Leader to have the said Bills corrected and republished for introduction in the Senate.

6. QUESTIONS AND STATEMENTS

a) Statement pursuant to Standing Order 52 (1)

The Senator for Nandi County (Sen. Samson Cherarkey, MP) made a Statement on a matter of national and general topical concern, namely; the Mai Mahiu floods tragedy that led to the death of over 45 people.

The Senator acknowledged the tragic events that unfolded in Mai Mahiu, Naivasha, where floods wreaked havoc, claiming the lives of over 45 individuals, injuring many others, and causing significant property damage and displacement. The incident, believed to have been triggered by water overflowing from a gulley in Kiambu County, had left the community reeling in grief and uncertainty.

The Senator urged all Kenyans to exercise caution amidst ongoing heavy rains across the nation. The Senator spoke of the need through investigations and for

prompt humanitarian aid to support the affected population, along with scrutiny of the Water Resource Management Authority's role in overseeing such infrastructure.

Drawing parallels with the Solai dam tragedy of 2018, the Senator raised called for accountability by government agencies such as the Water Resource Management Authority, National Environment Management Authority and National Construction Authority, and urged for comprehensive inspection reports on dams nationwide and measures to prevent similar incidents during the current rainy season. The Senator also criticized the Ministry of Transport and Housing for perceived neglect of infrastructure maintenance, particularly evident in deteriorating road conditions and inadequate drainage systems.

In conclusion, the Senator called for accountability and improved infrastructure management, reiterating that no more lives will be lost due to preventable circumstances, whether through individual responsibility or institutional failure.

c) Statement Pursuant to Standing Order 57(1)

The Senate Majority Leader issued a Statement on the business of the Senate for the week commencing Tuesday, 7th May, 2024.

d) Personal Statement pursuant to Standing Order 58

The Senator for Nandi County (Sen. Samson Cherarkey, MP) made a personal statement concerning the actions of social media platform X Corporation, formerly Twitter, in denying him assistance and access to his verified X account.

The Senator lamented the inaction of X Corporation since November 2023, which rendered his verified account on the platform inaccessible to over 329,700 Kenyan followers without explanation or resolution despite numerous attempts at contact.

The Senator added that X Corporation's silence amounted to the suppression of a vital channel of engagement between himself and the public, constituting a violation of freedom of speech and setting a perilous precedent. He argued that such actions disproportionately affect African nations and underscored the need for a robust response to prevent similar occurrences for Kenyan citizens in the future.

Proposing concrete actions to address the issue, the Senator called for an investigation by the Kenyan government into X Corporation's actions and urged diplomatic engagement with the American government to underscore the importance of ethical and responsible behaviour by multinational tech companies, especially when their services are paid for, irrespective of geographic location.

In conclusion, the Senator urged the Senate to support measures to protect the digital rights of every Kenyan, emphasizing that X Corporation's denial of access rights could and should be rectified promptly. He called for solidarity in ensuring that African voices are not silenced and that those attempting to do so are held accountable.

14. MOTION - STATUS OF PENDING BILLS IN COUNTIES

Order read;

Motion made and Question proposed;

AWARE THAT, as at 31st December, 2023, according to the County Governments Budget Implementation Review report for the first half of the financial year 2023/2024, County Governments had accumulated a total of Ksh.156.34 Billion shillings in pending bills with Nairobi City County accumulating the largest share of Ksh.107, 037,053,000 followed by Kiambu and Mombasa Counties at Kshs. 5,711,614,412 and Kshs. 3,922,131,877 respectively;

CONCERNED THAT, the accumulated pending bills in Counties have significantly affected service providers in the counties leading to closure of businesses, stalling of county projects, adversely affecting economic growth in counties, service delivery and ultimately slowing down the country's economic growth;

FURTHER CONCERNED, that most of the service providers in the counties are battling court cases lodged against them by their financiers and suppliers while others are languishing in poverty exacerbated by the increased cost of living, with increased mental health disease incidences and others dying as a result of the effects of colossal amounts of debt owed to them by county governments;

NOW THEREFORE, the Senate-

1. recommends that all County Governments pay verified pending bills amounting to less than Ksh. 1 Billion by the end of this financial year and those above Ksh.1 Billion by the end of the financial year 2024/2025; and

2. Resolves that-

- i. Pursuant to the provisions of Regulation 41(2) & (3) of the Public Finance Management (County Governments) Regulations, 2015, County Governments prioritize payment of pending bills as a first charge on the County Revenue Fund failure to which the subsequent quotas budget releases will not be done;
- ii. County Governments shall only pay pending Bills contained in their respective procurement plans pursuant to Regulation 50 (2) & (3) of the Public Finance Management (County Governments) Regulations;
- iii. Supplementary budgets for county governments are prepared in the 3rd Quarter to curb instances of arbitrary re-allocations out of the approved budget estimates; and
- iv. County governments shall conduct public participation while formulating supplementary budgets, failure to which the Controller of Budget (CoB) shall not approve the supplementary budgets.
