CHAIRPERSON'S FOREWORD

Mr. Speaker,

At its sitting held on Thursday, 2nd November, 2023, the Standing Committee on Devolution and Intergovernmental Relations received a copy of a letter, REF CGTN/DGVN/1/VOL.III (2), dated 1st November, 2023 from the Deputy Governor of Trans Nzoia County, Hon. Philomenah C. Kapkory addressed to the Deputy President and copied to the Speaker of the Senate. The Speaker then referred the matter to the Committee for its urgent consideration.

In the letter, the Deputy Governor brought the following issues to attention;

- a) that on 26th September, 2023 while on official duty in the United States of America (USA), she received information from concerned residents of Trans Nzoia County on some unfortunate happenings touching on her security and posing danger to her life;
- b) that in the said period, social media platforms were awash with threats and abuses levelled against her by the communication staff attached to the County Governor, Hon. George Natembeya. Her efforts to reach the Governor via phone calls were futile;
- c) that upon returning to the Country on 2nd October, 2023, she reported the threats to the Directorate of Criminal Investigations (DCI), the National Cohesion and Integration Commission (NCIC) and to Muthangari Police Station but no arrest or progress was made. She further wrote to the Governor informing him that she was unable to return to work in the County due to her compromised security situation;
- d) that even after writing to the Governor, the said staff of the Governor continued with the threats undeterred but the Governor never made any response on this;
- e) that additionally, the Governor himself continued making inflammatory statements which further threatened her security and caused a spiking animosity between her ethnic community and that of the Governor;
- f) She further revealed the difficult conditions she was working under including lack of funding for her office that was impacting on her ability to execute her duties as Deputy Governor, being denied her official residence which has been converted to a campaign centre and also the First Lady's office, being side-lined on all decisions and most functions in the County, being denied most of legitimate payments due to her and general mistreatment and humiliation that she has been subjected to;

g) She concluded by appealing to the Deputy President for an opportunity to meet with him in order to discuss a way of resolving the issues mentioned, for a healthy working relationship with the Governor and focus on service delivery in the County.

Mr. Speaker,

At the sitting, the Committee discussed the issues raised in the letter and resolved first to invite the Deputy Governor to deliberate on the aforementioned issues, then later invite the Governor on the same matter with the aim of resolving the issues and mediating the two. The Committee also resolved to engage relevant stakeholders, that is the Cabinet Secretary, Ministry of Interior and National Administration, the Inspector General of Police, the Director of Criminal Investigations and the National Cohesion and Integration Commission to deliberate further on the issues raised. The Committee sent invitations and successfully held meetings with the following stakeholders;

- a) The Deputy Governor of Trans Nzoia County on Monday, 6th November, 2023;
- b) The National Cohesion and Integration Commission on Monday, 20th November, 2023;
- c) The Governor of Trans Nzoia County on Monday, 27th November, 2023.

The Committee was not able to have a meeting with the Cabinet Secretary for Interior and National Administration, the Inspector General of Police and the Director of Criminal Investigations. The Cabinet Secretary was invited on two occasions. He conveyed his apologies and requested the Committee to reschedule the meeting to a more appropriate date when he would be available. Further, the Committee visited Trans Nzoia County on 22nd March 2024 and held a meeting with the Governor and the Deputy Governor with the aim of mediation and resolving the issues. The Committee later paid a courtesy call to the County Assembly of Trans Nzoia.

Mr. Speaker,

Upon receipt of the stakeholder submissions, the Committee did an in-depth analysis and based on its deliberations, the Committee has made various observations and recommendations which are set out in Chapter Four and Chapter Five of this report respectively.

Mr. Speaker,

I wish to inform the Senate that the Committee successfully resolved the issues causing the rift between the Governor and the Deputy Governor of Trans Nzoia County, mediated the two parties and restored a good working relationship between them.

May I take this opportunity to commend the Members of the Committee for their devotion and commitment to duty, which led to the successful consideration of the issues raised by the Deputy Governor of Trans Nzoia.

I also wish to thank the Offices of the Speaker and the Clerk of the Senate for the support extended to the Committee in undertaking this important assignment. Lastly, I wish to thank the stakeholders who appeared before the Committee and presented their submissions regarding the matter.

CHAPTER ONE: INTRODUCTION

1.1 Background

- 1. At its sitting held on Thursday, 2nd November, 2023 the Standing Committee on Devolution and Intergovernmental Relations was presented with a copy of a letter, REF CGTN/DGVN/1/VOL.III (2), dated 1st November, 2023 from the Deputy Governor of Trans Nzoia County, Hon. Philomenah C. Kapkory addressed to the Deputy President and copied to the Speaker of the Senate. (A copy of the letter is attached to this Report as Annex 2.)
- 2. In the letter, the Deputy Governor brought the following issues to attention;
 - a) that on 26th September, 2023 while on official duty in the United States of America (USA), she received information from concerned residents of Trans Nzoia County on some unfortunate happenings touching on her security and posing danger to her life;
 - b) that in the said period, social media platforms were awash with threats and abuses levelled against her by the communication staff attached to the County Governor, Hon. George Natembeya. Her efforts to reach the Governor via phone calls were futile;
 - c) that upon returning to the Country on 2nd October, 2023, she reported the threats to the Directorate of Criminal Investigations (DCI), the National Cohesion and Integration Commission (NCIC) and to Muthangari Police Station but no arrest or progress was made. She further wrote to the Governor informing him that she was unable to return to work in the County due to her compromised security situation;
 - d) that even after writing to the Governor, the said staff of the Governor continued with the threats undeterred but the Governor never made any response on this;
 - e) that additionally, the Governor himself continued making inflammatory statements which further threatened her security and caused a spiking animosity between her ethnic community and that of the Governor;
 - f) She further revealed the difficult conditions she was working under including: lack of funding for her office that was making it difficult for her to deliver service to the people as Deputy Governor, being denied her official residence which has been converted to a campaign centre/the First Lady's office, being side-lined on all decisions and most functions in the County, being denied most of legitimate payments due to her and general mistreatment and humiliation that she has been subjected to;
 - g) She concluded by appealing to the Deputy President for an opportunity to meet with him

in order to discuss a way of resolving the issues mentioned, for a healthy working relationship with the Governor and focus on service delivery in the County.

3. The Committee was informed that the Speaker had referred the matter to the Committee for its urgent consideration.

CHAPTER TWO: CONDUCT OF INQUIRY INTO THE MATTER

- 4. At the Committee sitting held on 2nd November, 2023, the Committee discussed the issues raised in the letter and resolved to invite the Deputy Governor to an urgent meeting of the Committee to be held on Monday, 6th November, 2023 to deliberate on the aforementioned issues.
- 5. The Committee also resolved to engage the County Governor after the meeting with the Deputy Governor to understand the wrangles and take the necessary measures to mediate between them.

2.1 Meeting with the Deputy Governor of Trans Nzoia County

- 6. On Monday, 6th November, 2023 the Committee met with Hon. Philomenah Kapkory, the Deputy Governor of Trans Nzoia County, to consider issues raised in the letter she sent to the Committee concerning her personal security.
- 7. The Deputy Governor took the Committee through various issues which she stated had compromised her personal security, affected her working relationship with the Governor and made it difficult for her to smoothly discharge her official duties and responsibilities. They included: security threats to her life, lack of facilitation to discharge official duties, ethnic profiling, mistreatment and intimidation, public vilification, disrespect by junior staff among others. Her submissions were as follows:

a) Threats to personal security and life

- 8. The Deputy Governor stated that on 26th September 2023, while attending the United Nations General Assembly (UNGA) conference in the United States of America (USA), she received several messages from concerned residents informing her of abusive and threatening posts on various social media platforms targeted at her. The threatening messages were posted by known County officials who are part of the Governor's communication team. She added that these messages were posted after a delegation of members of the Sabaot community made a presentation at the National Dialogue Committee insisting on the creation of a new county to be called Mt. Elgon County.
- 9. She reported that her efforts to contact the Governor by phone calls to raise the issues were futile hence she resorted to writing a letter to him. The Deputy Governor claimed that the Governor still ignored her communication and instead proceeded to tacitly endorse the said

threats in his public utterances.

b) Denial of use of designated residence of Deputy Governor

10. The Deputy Governor highlighted that the former Deputy Governor had handed over the keys to the official residence of the Deputy Governor on 26th August, 2023 but immediately after that, she was blocked from accessing or using the residence and was informed that there were plans to renovate the house before she could move in. She later learnt that the staff who were previously working at the Governor's campaign centre were now using the residence as an office. Additionally, she stated that the Governor's spouse was later allocated the same house as her office.

c) Exclusion, Discrimination and being side-lined in decision making and running of County Affairs

11. The Deputy Governor submitted that as the principal assistant to the Governor, she had never been accorded meaningful opportunity to discharge her functions effectively. She added that the Governor had constantly side-lined her in key meetings and functions, disregarded her advice on various aspects, arbitrarily reduced and delayed budgetary facilitation for operations in her office, and encouraged and condoned insubordination and disrespect by junior staff.

d) Communication breakdown

12. She claimed that all her efforts to reach the Governor through phone calls and messages were unsuccessful and instead, the Governor communicated to her through the County Secretary.

e) Ethnic profiling and incitement

13. Hon. Philomenah Kapkory stated that following the move by members of her community, the Sabaot, to petition for their county, she had been ethnically profiled by officers working in the Governor's office. She added that the Governor himself made pronouncements bordering on incitement against the said community which resulted in unhealthy ethnic tension.

f) Tracking and trailing by the Governor

- 14. Furthermore, she submitted that she received credible information that the Governor had been tracking and trailing her since writing the letter to him. This, she argued, is a violation of her constitutional right to privacy, which increases her worries and concerns about her personal security.
- 15. To prove her allegations, the Deputy Governor tabled nine videos and six screenshots of WhatsApp group conversations, as evidence of some of the aforementioned events. Most of

the videos were utterances made by the Governor at public events.

- 16. After explaining the above issues impacting on her ability to execute her duties and responsibilities, the Deputy Governor made the following prayers:
 - a) that the Senate through the Committee should make appropriate recommendations to the relevant state agencies to take action on reports made regarding the matter, i.e the NCIC, DCI and the Police;
 - b) that the Governor should give clarity on her roles as the Deputy Governor and a budget to enable effective execution of the functions; and
 - c) that the Committee should intervene in the current security threat to ensure her personal safety is guaranteed for her to freely work from the County.
- 17. Upon deliberations of the submissions made by the Deputy Governor of Trans Nzoia, the Committee resolved to invite the following stakeholders to a meeting of the Committee to deliberate further on the issues raised. These include:
 - a) Meeting with the Chairperson, of the National Cohesion and Integration Commission (NCIC) to be held on Monday, 20th November, 2023;
 - b) Meeting with the Cabinet Secretary, Ministry of Interior and National Administration, together with the Inspector General of Police and the Director of Criminal Investigations to be held on Thursday, 23rd November, 2023.
 - c) Meeting with the Governor, of Trans Nzoia County to be held on Monday, 27th November, 2023.

2.2 Meeting with the National Cohesion and Integration Commission (NCIC)

- 18. At its sitting held on Monday, 20th November, 2023 the Committee met with the Chairperson of the National Cohesion and Integration Commission (NCIC) to deliberate on the matter and get his submissions.
- 19. In his submissions, the Chairperson highlighted that on 3rd October 2023, the Deputy Governor of Trans Nzoia County reported to the NCIC about security threats she was facing in her line of duty as the Deputy Governor. In her statement, she claimed that her trouble began when the Sabaot Community started petitioning for a County of their own. She further alleged that the Governor of Trans Nzoia County, Hon. George Natembeya, MBS, is opposed to the creation of a county for the Sabaots and that he was on record stating that this will not happen despite

- their petition.
- 20. The Chairperson stated that the Deputy Governor further reported that on 23rd August 2023, the Governor remarked that the Sabaot should be satisfied with the employment positions they have been appointed in the county and should stop asking for a County of their own.
- 21. He informed the Committee that NCIC noted that the statements by the Governor led to frequent attacks on the Deputy Governor on social media platforms with threatening messages being directed to her.
- 22. The Chairperson reported that the commission had taken the following actions in handling the matter:
 - Commenced investigations on Governor Hon. George Natambeya, MBS, for Ethnic Contempt contrary to Sec 62(1) of the NCIC Act and Hate Speech contrary to section 13(1) of the NCIC Act No. 12 of 2008;
 - ii. Summoned the Governor to appear before the Commission on 28th November 2023; and
 - iii. Investigators from the Commission had travelled to the County to carry out ongoing ground investigations.
- 23. He concluded by stating that the Commission will submit its full report to the Committee once the investigations are complete.
- 24. The Committee resolved to allow the Commission to conclude its investigations and thereafter submit a copy of its report to the Committee. Submissions by NCIC are attached as **Annex 3**.

2.3 Meeting with the Governor of Trans Nzoia County

- 25. Following invitations by the Committee, the Governor of Trans Nzoia County Hon. George Natembeya, MBS, appeared before the Committee on Monday, 27th November, 2023 to deliberate on the matter.
- 26. In his submissions, the Governor dismissed all the allegations made by the Deputy Governor regarding administrative challenges impacting her ability to execute her official duties and responsibilities and regarded them as false and malicious.
- 27. He stated that his working relationship with the Deputy Governor was good until when the Deputy Governor left the Country to attend the United Nations General Assembly (UNGA) conference in the USA without his approval. He reported that the Deputy Governor processed

her invitation to the conference through the office of the Deputy President and only asked the County to facilitate her budget for the trip. Since the Governor did not approve it, the County could therefore not facilitate the budget. However, the Deputy Governor proceeded to attend the conference. It was at this point that communication between the Governor and the Deputy Governor broke down and the two never got into contact directly since then.

- 28. The Governor stated that he had not received any official complaint from the Deputy Governor regarding the issues she had raised. He further noted that the Deputy Governor is always invited to the Executive Committee meetings and County functions but she had not attended any of them since August 2023.
- 29. In addition, he highlighted that the official functions being performed by the Deputy Governor are those set out in the Constitution and other executive functions assigned to her by the Governor. He also noted that there is no residence officially designated for the Deputy Governor, instead the officeholder is given a house allowance which she should use to get a house on her own.
- 30. The Governor submitted that the Deputy Governor had been adequately facilitated, with a total budget of Ksh. 7 million having been released to her for office operations for the last year. He additionally stated that the County Government had plans to purchase another vehicle for the Deputy Governor's use.
- 31. The Governor concluded by informing the committee that he was very much willing to have the working relationship with the Deputy Governor restored. He stated that the issues impacting their relations could be solved amicably to have them run the county smoothly.

2.4 Meeting with the Cabinet Secretary, Ministry of Interior and National Administration

- 32. Upon invitations to attend a Committee meeting scheduled for Thursday, 23rd November 2023, the Cabinet Secretary wrote to the Committee conveying his apologies and requested that the meeting be postponed to Thursday, 30th November 2023.
- 33. The Cabinet Secretary failed to attend two Committee invitations where he conveyed his apologies and requested the Committee to reschedule the meeting to a more appropriate date when he would be available. Consequently, the Committee was not able to have a meeting with the Cabinet Secretary for the Ministry of Interior and National Administration.

2.5 County Visit to Trans Nzoia County

- 34. At its meeting held on Thursday, 7th March 2024, the Committee noted with concern that the agencies that are investigating the matter had taken too long to conclude their investigations.
- 35. Consequently, the Committee resolved to undertake a visit to Trans Nzoia County from 21st 23rd March 2024 to hold meetings with the Governor and the Deputy Governor to mediate over their simmering relations to foster a harmonious working relationship between them, interrogate and ensure the smooth running of the County affairs.

a) Meeting with the Governor and the Deputy Governor of Trans Nzoia County

- 36. The Committee visited Trans Nzoia County and held its meeting at the office of the Governor on 22nd March 2024. The Committee together with the Governor, the Deputy Governor and the County Commissioner of Trans Nzoia discussed the issues raised by the Deputy Governor and how they had affected her working relationship with the Governor to find amicable solutions.
- 37. Upon deliberations of the issues, it was agreed that there is need for the Deputy Governor and the Governor to bury the hatchet and work together for effective service delivery to the people. The Governor stated that the Deputy Governor was free to return to the office and assured her of her safety. He also committed to ensuring that the Deputy Governor's office is facilitated in time and that all the benefits due to her office shall be provided. The Deputy Governor agreed to return to office immediately and committed to work with the Governor to ensure the smooth running of County Affairs.
- 38. The County Commissioner of Trans Nzoia in his submissions assured the committee that he would ensure safety for the Deputy Governor and will handle any threats that she may encounter. He assured the Committee that Trans Nzoia is safe and Hon. Philomenah Kapkory can come back to her office to work.

b) Meeting with the County Assembly of Trans Nzoia

- 39. The Committee informed the Assembly that it had held a joint meeting between the Governor and the Deputy Governor which successfully resolved their long-standing dispute and further reported that the two agreed to work together and that the Deputy Governor was resuming back to office immediately.
- 40. The Members of the County Assembly thanked the Committee for taking up the initiative to

- mediate the Governor and the Deputy Governor and also reported that the County Assembly's women's caucus had considered the matter and had held a meeting with the Deputy Governor to find a way of having her concerns addressed.
- 41. The Committee urged the County Assembly to take up the role of initiating conflict resolution whenever there are such wrangles within the county that could hamper effective service delivery to the people.

CHAPTER THREE: ANALYSIS OF STAKEHOLDER SUBMISSIONS

3.1 Threats to personal security and life

- 42. The threats to the personal security and life of Hon. Philomenah Kapkory appeared to be a major issue that interfered with her official duties as the Deputy Governor of Trans Nzoia. In her submissions, she stated that while she was in the United States of America (USA), attending the United Nations General Assembly (UNGA) conference, she received several messages from concerned residents informing her of abusive and threatening posts on various social media platforms targeted at her. The threatening messages were posted by known County officials who are part of the Governor's communication team.
- 43. The Deputy Governor claimed that the threats began after a delegation of members of the Sabaot community made a presentation at the National Dialogue Committee insisting on the creation of a new county to be called Mt. Elgon County. She further alleged that the Governor of Trans Nzoia County, Hon. George Natembeya, MBS, is opposed to the creation of a county for the Sabaots and that he was on record stating that this will not happen despite their petition. She reported that her efforts to contact the Governor by phone calls to raise the issues were futile hence she resorted to writing a letter to him but the Governor still ignored her communication
- 44. The National Cohesion and Integration Commission (NCIC), in their submissions to the Committee, stated that they received the same report from the Deputy Governor of Trans Nzoia County, about security threats she was facing in her line of duty as the Deputy Governor. Hon. Philomenah Kapkory alleged that the Sabaot's petition for their own county led to frequent attacks on social media platforms with threatening messages being directed to her.
- 45. Upon receipt of this report, the NCIC commenced investigations on the Governor, summoned him to appear before the Commission and sent investigators to Trans Nzoia County to carry out ground investigations. The Chairperson NCIC stated that the Commission will submit its full report to the Committee once the investigations are complete.
- 46. During the Committee visit to Trans Nzoia County, the Governor stated that the Deputy Governor was free to return to the office and assured her of her safety.

3.2 Denial of use of designated residence of Deputy Governor

47. Hon. Philomenah Kapkory highlighted that she was handed over the keys to the official

residence of the Deputy Governor but immediately after that, she was blocked from accessing or using the residence and was informed that there were plans to renovate the house before she could move in. She later learnt that the staff who were previously working at the Governor's campaign centre were now using the residence as an office. Additionally, she stated that the Governor's spouse was later allocated the same house as her office.

48. With regards to this complaint, the Governor noted that there is no residence officially designated for the Deputy Governor, instead the officeholder is given a house allowance which she should use to get a house on her own.

3.3 Exclusion, Discrimination and being side-lined in decision making and running of County Affairs

- 49. In her submissions, the Deputy Governor claimed that she had never been accorded meaningful opportunity to discharge her functions effectively despite being the principal assistant to the Governor. She added that the Governor had constantly side-lined her in key meetings and functions, disregarded her advice on various aspects, arbitrarily reduced and delayed budgetary facilitation for operations in her office, and encouraged and condoned insubordination and disrespect by junior staff.
- 50. In response to the allegations, the Governor stated that he had not received any official complaint from the Deputy Governor regarding the issues she had raised. He further noted that the Deputy Governor is always invited to the Executive Committee meetings and County functions but she had not attended any of them since August 2023. In addition, he highlighted that the official functions being performed by the Deputy Governor are those set out in the Constitution and other executive functions assigned to her by the Governor.
- 51. Regarding facilitation, the Governor submitted that the Deputy Governor had been adequately facilitated, with a total budget of **Ksh. 7 million** having been released to her for office operations for the last year and added that the County Government had plans to purchase another vehicle for the Deputy Governor's use. In addition, he committed to ensure that the Deputy Governor's office is facilitated in time and that all the benefits due to her office shall be provided.

3.4 Communication breakdown

- 52. The Deputy Governor in her submissions to the committee claimed that all her efforts to reach the Governor through phone calls and messages were unsuccessful and instead, the Governor communicated to her through the County Secretary.
- 53. The Governor admitted that there was a communication breakdown between him and the Deputy Governor which was as a result of the Deputy Governor attending the UNGA conference in the USA without his approval. However, the Governor submitted that he was very much willing to have their communication and their working relationship with the Deputy Governor restored.

3.5 Ethnic profiling and incitement

- 54. Hon. Philomenah Kapkory stated that following the move by members of her community, the Sabaot, to petition for their own county, she had been ethnically profiled by officers working in the Governor's office. She added that the Governor himself made pronouncements bordering on incitement against the said community which resulted in unhealthy ethnic tension.
- 55. The Governor, during his submissions to the committee, disregarded all the allegations made by the Deputy Governor. Despite that, he stated that he was willing to amicably solve the issues impacting their relations so that they could run the County smoothly.

3.6 Tracking and trailing by the Governor

- 56. In her submissions, the Deputy Governor also stated that she received credible information that the Governor had been tracking and trailing her since writing the letter to him. This, she argued, is a violation of her constitutional right to privacy, which increases her worries and concerns about her personal security.
- 57. The County Commissioner of Trans Nzoia, during the meeting held at the Governor's office, assured the committee that he would ensure the safety of the Deputy Governor and would handle any threats that she may encounter. He assured the Committee that Trans Nzoia is safe and Hon. Philomenah Kapkory can come back to her office to work.


CHAPTER FOUR: COMMITTEE OBSERVATIONS

- 58. Having engaged with the Deputy Governor of Trans Nzoia Hon. Philomenah Kapkory, and other relevant stakeholders and analysing their submissions, the Committee observed that;
 - i. There was a simmering rift between the Governor and the Deputy Governor, even though both of them did not indicate of any major dispute or conflict happening to cause the issues reported.
 - ii. The work of the Deputy Governor had significantly been impacted by the communication breakdown between her and the Governor, the lack of a good working relationship with the Governor, lack of sufficient budgetary allocation to her office and also the security concerns and worries that she had.
 - iii. The ongoing rift between the Governor and the Deputy Governor was fuelling ethnic animosity amongst the communities living in Trans Nzoia County, mainly between the Governor's tribe (Luhya) and the Deputy Governor (Kalenjin). This may have ultimately affected other communities living in the County hence the need to resolve the dispute before it escalated.
 - iv. The National Cohesion and Integration Commission (NCIC) commenced investigations on the matter upon receipt of the report by the Deputy Governor. The Commission is yet to submit its full report to the Committee once the investigations are complete.
 - v. The Governor of Trans Nzoia was very much willing to have the working relationship with the Deputy Governor restored. He stated that the issues impacting their relations could be solved amicably to have them run the county smoothly.

CHAPTER FIVE: COMMITTEE RECOMMENDATIONS

- 59. Based on the findings and observations above, the Standing Committee on Devolution and Intergovernmental Relations recommends that;
 - i. Following a successful mediation and both parties agreeing to work together, the Committee recommends that the Governor and the Deputy Governor of Trans Nzoia should maintain the positive, harmonious and healthy working relationship for efficient and effective service delivery to the people of Trans Nzoia County.
 - ii. The office of the Deputy Governor should be sufficiently facilitated with budgetary allocation as well as adequate staff and a vehicle for its full operationalisation. This will ensure the Deputy Governor is facilitated to execute her mandate and responsibilities.
 - iii. The County Commissioner should ensure safety and security for the Deputy Governor as she returns to her office for her to comfortably work and serve the people of Trans Nzoia.
 - iv. Deputy Governors having challenges in delivering services at the County should take pre-emptive measures by writing to the Committee among other relevant agencies to seek assistance early enough before the issues escalate.
 - v. The Intergovernmental Relations Technical Committee (IGRTC) and other relevant agencies should intervene and resolve inter and intra governmental disputes and any other disputes in counties that threaten devolution.



- 1. The Committee considered Committee Paper No. 51 which was a brief outlining the issues the Deputy Governor of Trans Nzoia County, Hon. Philomenah Kapkory, brought to the attention of the Deputy President and the Speaker of the Senate vide a letter REF CGTN/DGVN/1/VOL.III (2) dated 1st November, 2023;
- 2. The Deputy Governor took the Committee through the various unfortunate happenings that have been taking place in the County that had compromised her personal security, affected her working relationship with the Governor and made it difficult for her to smoothly discharge her official roles. They included; security threats to her life, lack of facilitation to discharge official duties, ethnic profiling, mistreatment and intimidation, public vilification, disrespect by junior staff among others as explained below;

a) Threats to personal security and life

She stated that on 26th September, 2023 while attending the United Nations General Assembly (UNGA) in the USA, she received a number of messages from concerned residents informing her of abusive and threatening posts on various social media platforms targeted at her. The threatening messages were posted by known County officials who are part of the Governor's communication team. These messages were posted after a delegation of members of the Sabaot community made a presentation at the National Dialogue Committee in Nairobi, demanding for a creation of a new county to be called Mt. Elgon County.

She stated that she made efforts to reach the Governor and raise the issues with him and even further wrote a letter to him but the Governor ignored her communication and instead proceeded to tacitly endorse the said threats in his public utterances.

b) Denial of use of designated residence of Deputy Governor

She informed the Committee that the former Deputy Governor had handed over to her the keys to the official residence of the Deputy Governor on 26th August, 2023 but immediately after that, she was blocked from accessing or using the residence and was informed that there were plans to renovate the house before her moving in. She later learnt that the staff who were previously working at the Governor's campaign centre were now using the residence as an office. Additionally, the Governor's spouse was later allocated the same house as her office.

c) Exclusion, Discrimination and being sidelined in decision making and running of County Affairs

She stated that as the principal assistant to the Governor, she had never been accorded meaningful opportunity to discharge functions effectively. The Governor has constantly sidelined her in key meetings and functions and even disregarded her advice on various aspects, arbitrary reduction and delay of budgetary facilitation for legitimate operations in her office, encouraging and condoning insubordination and disrespect by junior staff, etc.

d) Communication breakdown

She reported that all her efforts to reach the Governor through phone calls and messages had borne no fruit. Instead, the Governor communicates to her through the County Secretary.

e) Ethnic profiling and incitement

She stated that following the move by members of her community, the Sabaot, to petition for their own county, she has been ethnically profiled by persons working in the Governor's office. That the Governor himself has been making pronouncements bordering on incitement against the said community which has resulted in unhealthy ethnic tension.

f) Tracking and trailing by the Governor

That she received credible information that the Governor has been tracking and trailing her since writing the letter to him. This, she argued, is a violation of her constitutional right and privacy which exacerbates her worries and concerns about her personal security.

3. To Proof her allegations, the Deputy Governor tabled nine videos and six screenshots of WhatsApp group conversations, as evidence of some of the

aforementioned events. Most of the videos were utterances made by the Governor in public events;

- 4. After explaining the above issues impacting on her ability to execute her duties and responsibilities as Deputy Governor, she made the following prayers;
 - a) that the Senate through the Committee to make appropriate recommendations to the relevant state agencies to take action on reports made regarding the matter, i.e the NCIC, DCI and the Police;
 - b) that the Governor gives clarity on her roles as the Deputy Governor and a budget to enable effective execution of the functions;
 - c) that the County Government to give adequate facilitation in terms of budget to her office to enable her carry out her mandate;
 - d) that the Committee intervenes on the current security threat to ensure her personal safety is guaranteed for her to freely work from the County.

After the submissions from the Deputy Governor, the Committee deliberated on the agenda and resolved to invite the following stakeholders to a meeting of the Committee to deliberate further on the issues raised;

- 1. the Chairperson, of the National Cohesion and Integration Commission (NCIC) to be held on Monday, 20th November, 2023;

MEETING WITH THE CHAIRPERSON OF THE NATIONAL COHESION AND INTEGRATION COMMISSION TO CONSIDER ISSUES CONCERNING THE PERSONAL SECURITY OF HON. PHILLOMENAH KAPKORY, DEPUTY GOVERNOR OF TRANS NZOIA COUNTY

The Committee took note of the contents of Committee Paper No. 54, a brief on the meeting with the Chairperson of the National Cohesion and Integration Commission (NCIC) for consideration of issues concerning the personal security of the Deputy Governor of Trans Nzoia County. The paper analyzed the submissions made by the Deputy Governor during her appearance before the Committee as well as the resolutions made at the meeting.

Thereafter, the Committee invited the Chairperson of NCIC to make his submissions to the Committee on the matter. He submitted as follows -

- 1. That on 3rd October, 2023 Hon. Philomenah Kapkory, the Deputy Governor of Trans Nzoia County reported to the National Cohesion and Integration Commission about security threats she was facing in line of duty as the Deputy Governor;
- 2. That in her statement, the Deputy Governor claimed the issues began when leaders and elders of the Sabaot community started petitioning for their own county when they appeared before the National Dialogue Committee;

- 3. In the statement, the Deputy Governor alleged that the Governor of Trans Nzoia County, Hon. George Natembeya, MBS, is opposed to the creation of a county for the Sabaots and that he is on record stating that the Saboats will not get any county despite their petition for the same;
- 4. The Deputy Governor further reported that on 23rd August 2023, the Governor remarked that the Sabaot should be satisfied with the employment positions they have been appointed in the county and should stop asking for a County of their own. He further went on to state that not even an inch of Trans Nzoia County would be hived off to another county, insinuating that the Sabaots are greedy;
- 5. He noted that the statement by the Governor had led to frequent attacks on the Deputy Governor on social media platforms with threatening messages being directed to her;
- 6. He reported that the commission had taken the following actions:
 - a) Commenced investigations on Governor Hon. George Natambeya, MBS, for Ethnic Contempt contrary to Sec 62(1) of NCIC Act and Hate Speech contrary to section 13(1) of the NCIC Act No. 12 of 2008;
 - b) Summoned the Governor to appear before the Commission on 28th November, 2023; and
 - c) Investigators from the Commission had travelled to the County to carry out ground investigations which were ongoing.

He concluded by stating that the Commission will submit its full report to the Committee once it concludes its investigations.

Resolution.

The Committee resolved to allow the Commission to conclude its investigations and thereafter submit a copy of its report to the Committee.

MEETING WITH HON. GEORGE NATEMBEYA, MBS, GOVERNOR OF TRANS NZOIA COUNTY, TO CONSIDER MATTERS CONCERNING THE PERSONAL SECURITY AND ADMINISTRATIVE ISSUES OF HON. PHILLOMENAH KAPKORY, DEPUTY GOVERNOR OF TRANS NZOIA COUNTY

1. The Committee considered Committee Paper No. 55, a brief on the meeting of the Committee with the Governor of Trans Nzoia County for consideration of issues concerning the personal security of Hon. Philomenah Kapkory, the Deputy Governor of Trans Nzoia County, and took note of its contents thereof. The paper

analyzed the submissions made by the Deputy Governor during her appearance before the Committee and further synthesized the issues arising from the submissions;

- 2. Thereafter, the Committee took the Governor through the various issues that the Deputy Governor reported to have compromised on her personal security, affected her working relationship with the Governor and made it difficult for her to execute her official roles. They included; security threats to her life, lack of facilitation to discharge official duties, ethnic profiling, mistreatment and intimidation, public vilification, and disrespect by junior staff among others;
- 3. A copy of the letter that the Deputy Governor wrote to the Deputy President and copied to the Speaker of the Senate on the aforementioned issues was shared to the Governor. Additionally, the videos clips that were presented by the Deputy Governor as proof of some of her allegations were also played in the meeting.
- 4. Thereafter, the acting Chairperson invited the Governor to make his response to the Committee on the issues raised by the Deputy Governor. He submitted as follows
 - a) he dismissed all the allegations made by the Deputy Governor regarding administrative challenges impacting her ability to execute her official duties and responsibilities, are false and malicious;
 - b) that his working relationship with the Deputy Governor was very good until when the Deputy Governor left the Country to attend the United Nations General Assembly conference in the US without approval from the Governor. He reported that the Deputy Governor secretly processed her invitation to the conference through the office of the Deputy President and only asked the County to facilitate her budget for the trip. Since the Governor did not approve it, the County could therefore not facilitate the budget. However, the Deputy Governor proceeded to attend the conference. It is at this point that communication between them broke down and the two never got into contact directly since then;
 - c) informed the meeting that he had not received any official complaint from the Deputy Governor regarding the issues she had raised;

- d) that the Deputy Governor is always invited to the Executive Committee meetings and County functions but she had not attended any of them since the month of August 2023;
- e) that the official functions being performed by the Deputy Governor are those set out in the Constitution and other executive functions assigned to her by the Governor;
- f) that there is no residence officially designated for the Deputy Governor, instead the officeholder is given a house allowance which she should use to get a house on her own;
- g) that the Deputy Governor has been adequately facilitated, with a total budget of Ksh. 7 million having been released to her for office operations for the last one year. He additionally stated that the County Government had plans to purchase another vehicle for the DG's use;
- h) that as Governor, he had not ethnically profiled any person or community living in the County but instead he had always endeavoured to promote cohesion and integration of all communities in the county;
- i) he stated that he held different views on the proposal made by some members of the Sabaot community on creating a new county by separating from Trans Nzoia County. He however submitted that his position has not interfered with or undermined the efforts of those who were in support of their proposal for it was within their right;
- j) stated that he had not disregarded any advice given to him by the Deputy Governor. As Governor, he considers advice given to him by the County Executive in its official meetings which the Deputy Governor had not been attending despite being a member;
- k) that as Governor, he had no mandate of taking disciplinary action against the junior officers whom the Deputy Governor had accused of threatening and intimidating her as that was the role of the County Public Service Board;
- he refuted claims that the procurement of maize seeds for farmers by the County Government was done irregularly. He informed the meeting that the purchase of the seeds was done transparently and in accordance with the open tender procurement rules;

- 5. to support his commitment of championing for cohesion among the various ethnic communities in the County, the Governor played videos of his public utterances in which he called for unity among all the residents of the county:
- 6. concluded by informing the committee that he was very much willing to have the working relationship with the Deputy Governor restored. He stated that the issues impacting their relations could be solved amicably to have them run the county smoothly.
- 7. After the Governor addressed the concerns raised by the members, the Committee appealed to the Governor to initiate reconciliation with the Deputy Governor and try solve their differences amicably even as the external agencies were looking into the matter.

Resolution. &

Upon deliberations, the Committee resolved to allow the relevant agencies that are investigating the matter i.e the Directorate of Criminal Investigations, the National Police Service and the National Cohesion and Integration Commission to conclude their investigations and thereafter share their reports with the Committee.

Your Excellency, I trust this mail finds you well.

My name is Philomenah Bineah Kapkory, the Deputy Governor, Trans Nzoia County. I am a hardworking Kenyan leader with a sterling performance record throughout my working career in the banking industry where I was before joining politics. I am a person of integrity with a strong sense of responsibility and service delivery as I am passionate about putting people first.

Your Excellency, I write to escalate to you an issue of critical importance that is impacting my ability to deliver on my mandate to serve the people of Trans Nzoia as the Deputy Governor. This is in regard to my personal which security which has been threatened therefore not allowing me to perform and execute my duties and responsibilities as envisaged by the constitution.

On 26th September, while I was in the US attending the United Nations General Assembly (UNGA) I was informed by concerned residents of Trans Nzoia of some unfortunate happenings touching on my security and posing danger to my life. The social media platforms were awash with threats and abuses leveled against me by the communication staff attached to the Governor, George Natembeya. I immediately I called the Governor via WhatsApp twice but he did not pick up my calls. I then followed up on 28th September with a text message and even forwarded to him some of the threatening messages on WhatsApp but he did not respond.

Upon my return to the country on 2nd October 2023, I reported these threats to the DCI, NCIC and to Muthangari Police Station but unfortunately till now no arrests have been made and there has been no progress. I also wrote a letter to the Governor informing him that I was unable to return to work in the County but was happy to serve from a different location due to my compromised security. So far, I have written two letters to the Governor and both have remained unresponded to. I decided to write these letters because other forms of communication went unanswered. (I have attached herein copies of these letters).

Your Excellency, what is odd is that the said staff boldly continued with this for over three weeks undeterred and one of them even recorded himself on video to address me directly. These messages

and the videos have been availed to the DCI, NCIC and the Police and I am happy to share them. The Governor has completely refused to address the matter and neither has he taken action against the staff concerned. Political leaders, elders and church leaders have tried to talk to him but he has refused to address the issue. I have also informed the County Commissioner who has assured me of my safety but I feel my security is still compromised as the perpetrators are going about their business as usual in the County. Additionally, the Governor has continued to make inflammatory statements which further threaten my security (videos to that effect are available). These are comments that incite animosity between communities and as we speak there is a lot of tension between his community and mine. This is uncalled for and goes against the tenets of cohesion and peace which negatively impacts devolution.

Your Excellency, due to this matter remaining unresolved, I am still not able to go back to the office in Trans Nzoia. I am currently in Nairobi as I feel it is not safe operating from my office the way things stand.

Your Excellency, I want to take this opportunity to also escalate the conditions under which I work some of which include lack of funding for my office which makes it difficult for me to deliver; being assigned a newly created department (GDU) with zero budget thus impacting on ability of deliver; being denied my official residence which was converted to a campaign centre/ the First Lady's office; being sidelined on all decisions and most functions in the County; being denied some of legitimate payments due to me. I have undergone untold humiliation and mistreatment which I have respectfully and quietly persevered with but now I come to you for help as it has gone overboard and is not sustainable.

Your Excellency, I take this chance to request an opportunity to meet you to give further details on these issues with the goal of resolving them to pave way for a healthy working relationship and focus on service delivery in the County.



PRESENTATION TO THE SENATE STANDING COMMITTEE ON DEVOLUTION AND INTERGOVERNMENTAL RELATIONS

INTRODUCTION

The office of the Deputy Governor is created under Article 180 of the Constitution of Kenya, 2010. The functions of the Deputy Governor are defined under section 32 of the county Government Act, 2012. I was elected on a joint ticket with Governor George Natembeya on 9th August, 2022 and sworn in on 25th August, 2022.

Immediately thereafter, I embarked on duties and assignments on specific tasks assigned by the Governor from to time. During these early days, I made various suggestions to the Governor on duties I could run with to improve on delivery of services by the County, but he declined.

However, late last year, the Governor assigned me several the duties via an executive order. One the duties included heading the Governor's Delivery Unit, whose mandate is to track and monitor progress of all projects and programmes initiated by the county government. However, there was no budget assigned for the discharge of these functions.

Since assumption to office, I have not had the opportunity to effectively discharge my roles due to a number of factors and reasons. My predicaments as Deputy Governor border on lack of facilitation to discharge duties, contempt, mistreatment, intimidation, security and threats to life, public vilification, and deliberate acts of disrespect by junior county staff, among others. The situation became worse in the month of September, 2023, when I received threatening and intimidating information initiated by the communication staff attached to the Governor's office.

Owing to the above circumstances, I made an official communication to the Office of the Deputy President and to this House, seeking for intervention and possible resolution of these issues.

SUMMARY OF THE ISSUES

1. Threats to Personal Security and Life

- a. Threats towards me via WhatsApp chats and Facebook posts.
- b. Persistently making demeaning public utterances against me.

a. Threats

On 26th September, 2023, while I was in the United States attending the United Nations General Assembly (UNGA), I received a number of messages from concerned residents informing me of abusive and threatening posts on various social media platforms targeted at me. The threatening message were posted by known officials who are part of the Governor's communication team. These messages were published/posted after a delegation of members of the Sabaot community made a presentation at the National Dialogue Committee at Bomas in Nairobi, demanding for the creation of an extra county.

The threats issued against me were personal and the constant message was that I am not required to step in my office as I had become a "persona non-grata" and that "the DG should not step at town hall." The threats were to the effect that if I stepped in the office or if I was seen, the said officials were ready "to deal with me; ... that I should "prepare for the worst; ... that they had taken oaths; ... that they were ready to take in bullets;...kama ni mbaya mbaya; that they would not handle the issue politely when violence could solve it;... that "you must expect the worst to happen; ... that "the world is cruel when you go against the boss..."

Some of the messages are captured in the screenshots shown in *annexture 1*, with the most lethal messages being issued by one Sammy Edambo whose personal contact information is discernible from the screenshots.

I made efforts to reach the Governor and raise these issues with him, and further wrote a letter dated 4th October, 2023. However, the Governor ignored and/or disregarded my communication and instead proceeded to tacitly endorse the said threats by making public utterances meant to further damage my dignity.

Following my formal communication to the Governor through the letter dated 4th October, 2023, one of the communication's officer attached to the Governor's office, one Sammy Edambo, went ahead to record and circulate a video in which he directly addressed me. In that video, the official is heard abusing me using unprintable words like "wacha upuzi yako, wacha ujinga, hatukuogopi, tutadeal na wewe, and threating to deal with me. The words used in the video were not only demeaning and disrespectful, but they also amounted to threats to my personal security and life. . [See the video clips No 1 in the flashdisk attached hereto].

b. No action was taken by Governor

Once the threats were issued from the Governor's communications officers and close aides, whose offices and roles is bear the name and honour of the Officer of the Governor, it was important for the Governor to immediately intervene and address the issue administratively, but his inaction and subsequent speeches raised a lot of questions.

Despite receiving communication from me, the Governor never took any action. Instead, the Governor joined in the public vilification, giving public speeches meant to defame, demean and further disrespect me. [See the video clips Nos 2-8 in the flashdisk attached hereto]. In the video clips, the Governor can be heard uttering words meant to spur ethnic animosity, incite communities against each other, and create a false impression that a certain community is under threat/attack. The impression created in one of the video clips (No T) is that during a recent funeral/burial ceremony, members of a community were armed with dangerous weapons, and that him (the Governor) is being targeted. The import of the message is to inspire ethnic animosity and hatred, and to incite a section of the community against me as a person. This exposes me to grave danger from some resident members of the county who were falsely made to believe that I was behind the alleged arming of citizens (See video No 2 and 3).

c. No action from security agencies

I reported the issue at Muthangari Police Station and also to the Director of Criminal Investigations (DCI). I also reported the matter formally to the National Cohesion and Integration Commission (NCIC). The DCI is yet to take action, one month down the line, despite follow ups.

d. Tracking and trailing me

I have been receiving credible information that Governor Natembeya has been tracking and trailing me since I wrote the letter dated 4th October, 2021. This is in violation of my constitutional right to privacy, and it exacerbates my worries and concerns about my personal security.

2. Denial of use of Designated Residence as Deputy Governor

The former Deputy Governor handed over to me the keys to the official residence of the Deputy Governor on 26th August, 2022, but immediately after that, I was blocked from accessing or using the residence. I was informed that there were plans to renovate the house before moving in and while I was preparing myself, I was blocked from accessing it. I later learnt that the staff who had were previously working at the Governor's campaign center were now using the residence as an office. The Governor's spouse was later allocated the same house as her office. I have never been given an alternative official residence.

3. Exclusion, Discrimination and being sidelined in decision making and running of County Affairs

As the Deputy Governor and the principal assistant to the Governor, I have never been accorded a meaningful opportunity to discharge functions effectively. I have constantly been sidelined in key meetings and functions and my advice on various aspects has often been disregarded. In breach of Articles 10, 19 (2), 28, 73, 75 and 179 of the Constitution, (ii) sections 9 (b), 19 and 24 of the Public Officer Ethics Act, (iii) sections 29 and 34 of the Leadership and Integrity Act and (iv) sections 30 (2) and (3) (c) and (d) of the County Governments Act, the Governor has sidelined me in the issues of county governance, and he has subjected me to bullying, intimidation and mockery by junior county staff. Some particulars instances include:

a) Exclusion from key meetings and other county functions.

b) Encouraging and condoning bullying, undermining and posting insulting and demeaning messages about me.

c) Encouraging and condoning insubordination and disrespect by some members of the executive and junior staff.

- d) Arbitrary reduction and delay of budgetary facilitation for legitimate operations of my office.
- e) One old vehicle.
- f) Imprest /DSA/Per diem.

Some of the notable instances where I have offered advice in vain and/or where my input as the Principal Assistant has not been considered include.

- a. Employment: Cases of nepotism in the employment processes have been averse, and despite my advice, relatives were employed to key positions.
- b. There have been cases of violations of the law in appointments to the County Government, including instances where the Governor has usurped the roles of the County Public Service Board eg in the recruitment of kazi mtaani staff, directors, etc. I was concerned that these was a gross violation of (i) Articles 10, 232, and 236 of the Constitution, (ii) section 17 of the Public Officer Ethics Act, (iii) sections 45, 55, 59A, 60, 62, 63, 64 and 65 of the County Governments Act, (iv) section 4 of the Public Appointments (County Assemblies Approval) Act, 2017, (v) section 34 (3) of the Public Service Commission Act, 2017.
- c. Seeds project: I offered advice of a cheaper and more efficient approach on procurement of maize seeds by the county government, but the Governor chose a more expensive approach.
- d. Demolitions: I advised the Governor against the move to initiate blanket demolitions of houses and structures surrounding the issue of alleged grabbing of public land, and instead take each case on its merit, but the Governor went ahead to initiate haphazard demolitions. We are now facing legal suits challenging these actions.

4. Communication Breakdown

There has been a complete communication breakdown between me and the Governor. All my efforts to reach the Governor through phone calls and messages have borne no fruits. The Governor has not been responding to my communication. Instead, he communicates to me through the County Secretary and other junior officers including the Chief Officer in charge of Governance.


5. Ethnic Profiling And Incitement


Following the move by members of the Sabaot community to petition for a county, I have been ethnically profiled and attacked by persons working in the Governor's office. The Governor himself has been on the forefront in viciously opposing the creation of an extra county, and while at it, he has been making public pronouncements bordering on incitement against the said community. This has degenerated into messy and vicious fights on social media platforms by members of two communities and has resulted in unhealthy tension (See videos 4-8).



Owing to the above circumstances, I made an official communication to the Office of the Deputy President and to this House, seeking for intervention and possible resolution of these issues.

SUMMARY OF THE ISSUES

1. Threats to Personal Security and Life

- a. Threats towards me via WhatsApp chats and Facebook posts.
- b. Persistently making demeaning public utterances against me.

a. Threats

On 26th September, 2023, while I was in the United States attending the United Nations General Assembly (UNGA), I received a number of messages from concerned residents informing me of abusive and threatening posts on various social media platforms targeted at me. The threatening message were posted by known officials who are part of the Governor's communication team. These messages were published/posted after a delegation of members of the Sabaot community made a presentation at the National Dialogue Committee at Bomas in Nairobi, demanding for the creation of an extra county.

The threats issued against me were personal and the constant message was that I am not required to step in my office as I had become a "persona non-grata" and that "the DG should not step at town hall." The threats were to the effect that if I stepped in the office or if I was seen, the said officials were ready "to deal with me; ... that I should "prepare for the worst; ... that they had taken oaths; ... that they were ready to take in bullets;...kama ni mbaya mbaya; that they would not handle the issue politely when violence could solve it;... that "you must expect the worst to happen; ... that "the world is cruel when you go against the boss..."

Some of the messages are captured in the screenshots shown in *annexture 1*, with the most lethal messages being issued by one Sammy Edambo whose personal contact information is discernible from the screenshots.

I made efforts to reach the Governor and raise these issues with him, and further wrote a letter dated 4th October, 2023. However, the Governor ignored and/or disregarded my communication and instead proceeded to tacitly endorse the said threats by making public utterances meant to further damage my dignity.

Following my formal communication to the Governor through the letter dated 4th October, 2023, one of the communication's officer attached to the Governor's office, one Sammy Edambo, went ahead to record and circulate a video in which he directly addressed me. In that video, the official is heard abusing me using unprintable words like "wacha upuzi yako, wacha ujinga, hatukuogopi, tutadeal na wewe, and threating to deal with me. The words used in the video were not only demeaning and disrespectful, but they also amounted to threats to my personal security and life. . [See the video clips No 1 in the flashdisk attached hereto].

b. No action was taken by Governor

Once the threats were issued from the Governor's communications officers and close aides, whose offices and roles is bear the name and honour of the Officer of the Governor, it was important for the Governor to immediately intervene and address the issue administratively, but his inaction and subsequent speeches raised a lot of questions.

Despite receiving communication from me, the Governor never took any action. Instead, the Governor joined in the public vilification, giving public speeches meant to defame, demean and further disrespect me. [See the video clips Nos 2-8 in the flashdisk attached hereto]. In the video clips, the Governor can be heard uttering words meant to spur ethnic animosity, incite communities against each other, and create a false impression that a certain community is under threat/attack. The impression created in one of the video clips (No 2) is that during a recent funeral/burial ceremony, members of a community were armed with dangerous weapons, and that him (the Governor) is being targeted. The import of the message is to inspire ethnic animosity and hatred, and to incite a section of the community against me as a person. This exposes me to grave danger from some resident members of the county who were falsely made to believe that I was behind the alleged arming of citizens (See video No 2 and 3).

c. No action from security agencies

I reported the issue at Muthangari Police Station and also to the Director of Criminal Investigations (DCI). I also reported the matter formally to the National Cohesion and Integration Commission (NCIC). The DCI is yet to take action, one month down the line, despite follow ups.

d. Tracking and trailing me

I have been receiving credible information that Governor Natembeya has been tracking and trailing me since I wrote the letter dated 4th October, 2021. This is in violation of my constitutional right to privacy, and it exacerbates my worries and concerns about my personal security.

2. Denial of use of Designated Residence as Deputy Governor

The former Deputy Governor handed over to me the keys to the official residence of the Deputy Governor on 26th August, 2022, but immediately after that, I was blocked from accessing or using the residence. I was informed that there were plans to renovate the house before moving in and while I was preparing myself, I was blocked from accessing it. I later learnt that the staff who had were previously working at the Governor's campaign center were now using the residence as an office. The Governor's spouse was later allocated the same house as her office. I have never been given an alternative official residence.

3. Exclusion, Discrimination and being sidelined in decision making and running of County Affairs

As the Deputy Governor and the principal assistant to the Governor, I have never been accorded a meaningful opportunity to discharge functions effectively. I have constantly been sidelined in key meetings and functions and my advice on various aspects has often been disregarded. In breach of Articles 10, 19 (2), 28, 73, 75 and 179 of the Constitution, (ii) sections 9 (b), 19 and 24 of the Public Officer Ethics Act, (iii) sections 29 and 34 of the Leadership and Integrity Act and (iv) sections 30 (2) and (3) (c) and (d) of the County Governments Act, the Governor has sidelined me in the issues of county governance, and he has subjected me to bullying, intimidation and mockery by junior county staff. Some particulars instances include:

a) Exclusion from key meetings and other county functions.

b) Encouraging and condoning bullying, undermining and posting insulting and demeaning messages about me.

c) Encouraging and condoning insubordination and disrespect by some members of the executive and junior staff.

d) Arbitrary reduction and delay of budgetary facilitation for legitimate operations of my office.

e) One old vehicle.

f) Imprest /DSA/Per diem.

Some of the notable instances where I have offered advice in vain and/or where my input as the Principal Assistant has not been considered include.

- a. Employment: Cases of nepotism in the employment processes have been averse, and despite my advice, relatives were employed to key positions.
- b. There have been cases of violations of the law in appointments to the County Government, including instances where the Governor has usurped the roles of the County Public Service Board eg in the recruitment of kazi mtaani staff, directors, etc. I was concerned that these was a gross violation of (i) Articles 10, 232, and 236 of the Constitution, (ii) section 17 of the Public Officer Ethics Act, (iii) sections 45, 55, 59A, 60, 62, 63, 64 and 65 of the County Governments Act, (iv) section 4 of the Public Appointments (County Assemblies Approval) Act, 2017, (v) section 34 (3) of the Public Service Commission Act, 2017.
- c. Seeds project: I offered advice of a cheaper and more efficient approach on procurement of maize seeds by the county government, but the Governor chose a more expensive approach.
- d. Demolitions: I advised the Governor against the move to initiate blanket demolitions of houses and structures surrounding the issue of alleged grabbing of public land, and instead take each case on its merit, but the Governor went ahead to initiate haphazard demolitions. We are now facing legal suits challenging these actions.

4. Communication Breakdown

There has been a complete communication breakdown between me and the Governor. All my efforts to reach the Governor through phone calls and messages have borne no fruits. The Governor has not been responding to my communication. Instead, he communicates to me through the County Secretary and other junior officers including the Chief Officer in charge of Governance.


5. Ethnic Profiling And Incitement

Following the move by members of the Sabaot community to petition for a county, I have been ethnically profiled and attacked by persons working in the Governor's office. The Governor himself has been on the forefront in viciously opposing the creation of an extra county, and while at it, he has been making public pronouncements bordering on incitement against the said community. This has degenerated into messy and vicious fights on social media platforms by members of two communities and has resulted in unhealthy tension (See videos 4-8).

PRAYERS

- a. Security: I would like to discharge my constitutional duties in an environment that is secure.
- b. Facilitation: My office should be facilitated to enable me carry out my mandate
- c. Clarity of roles and a budget to enable execution.
- d. The House to make appropriate recommendations for relevant state agencies to take action on reports made, that is, DCI.







RESPONSE TO THE SUMMONS BY STANDING COMMITTEE ON DEVOLUTION AND INTERGOVERNMENTAL RELATIONS

Chair and Honourable members of the committee,

- 1. I received your letter dated 10th November, 2023 requiring my attendance to this committee and shed light on the issue at hand and I wish to state as follows;
- 2. <u>WHEREAS</u> I recognize the role of the senate to oversight the County Governments under Article 96 of the Constitution;
- 3. <u>WHEREAS</u> I recognize the establishment of the Standing Committee on Devolution and Intergovernmental relations understanding order 228(3) of the Senate Standing Orders

AND

4. <u>WHEREAS</u> I recognize the invaluable role of the Standing Committee on Devolution and Intergovernmental relations under the fourth schedule of the Senate Standing Orders of the Senate being to consider all matters relating to "devolution, intergovernmental and inter-county relations, governance and management of county governments, cities, towns and urban areas."

AND

5. <u>WHEREAS</u> the Senate has powers to summon a witness or any other person as it deems appropriate in advancement of its mandate under order 205 the Senate Standing Orders of the Senate;

Honourable Members, permit me to respond as thus on the wild allegations laid against me by the Deputy Governor:

A. Threats to Personal Security and Life

Under this issue, the DG has raised two-fold matters that I will deal with sequentially:

a. Alleged threats towards the DG via WhatsApp and Facebook posts

- 1. The DG has blamed my communication officer, Sammy Edambo for allegedly threatening her. I have talked to Mr. Edambo about this matter, and he has categorically denied ever issuing any threats whether on WhatsApp or Facebook or anywhere else.
- 2. In her statement, the DG indicates that she received a number of messages from **concerned residents** informing her of the abusive and threatening posts allegedly posted on various sites, however, she does not disclose the identity of this purported concerned residents.
- 3. It follows, that the DG's complaint is based on **hearsay** and **rumors** as it is communication coming from unknown third parties who have not been brought before this committee.
- 4. Honourable Members, the nature of this complaint, is criminal in nature, in that issues regarding personal security fall within the province of the National Government under the National Police Service; and the same is well regulated in our country's well established criminal justice system.
 - 5. The National Police Service with its partners within the multiagency framework have both a constitutional obligation under Article 244 of the Constitution of Kenya and the National Police Service Act to maintain law and order as well as protect life and property. (Section 24 of the National Police Service Act).
 - 6. The Deputy Governor has not availed any evidence (in form of an OB Extract or otherwise) before this Committee that she has reported this matter to Kenya Police to investigate the same.
 - 7. The DG purports that she made a report at Muthangari Police Station within Lavington area in Nairobi, one would wonder why she made a report at Muthangari instead of

 (\cdot,\cdot)

Kitale Police Station, which is the station within the local limits where the threats were allegedly made and therefore closer to the incident (if any at all).

b. No action was taken by Governor

- 8. The DG has never raised any complaint to me about the alleged threats to her security and safety.
- 9. As a matter of fact, the DG has absconded duty from around 14th September,2023 to date and therefore she has been unavailable within the County Offices for a discussion on any emerging issue.
- 10. If indeed she had made me aware, I could have advised her to report the matter to police.
- 11. In any event, I am not an authorized officer to initiate disciplinary action against any county employee. The County has established channels of redress which include first raising such an issue with the relevant Chief Officer, and in this case, the Chief Officer Governance who may escalate the matter to the County Public Service Board as the case maybe.
- 12. In this particular instance, I am not aware if the Deputy Governor pursued these channels that she is well aware of.

c. Purported Tracking and trailing the DG

- 13. This allegation confirms that indeed the entire complaint is a frivolous and scandalous one. I do not have the necessary tools to track and trail anyone.
- 14. In any event, and for argument sake only, I have no reason at all to track and trail a state officer who has abdicated and deserted her responsibilities as a DG.

B. Purported Denial of use of Designated Residence as Deputy Governor

- 15. The DG is entitled to a House Allowance of Kshs.100,000 per month to which she has been issued with every month.
- 16. Just like the DG, I too, do not have an official residence.
- 17. This complaint has no basis at all.

()()

C. <u>Purported Exclusion</u>, <u>Discrimination and being sidelined in decision making and running of County Affairs</u>

i. No budgetary allocation for her duties

18. The department of governance under the office of the Governor facilitates the Governor and Deputy Governor. There is evidence to confirm that the DG's office has been facilitated sufficiently.

ii. Exclusion from key meetings and other county functions

19. The DG has always been invited to Cabinet Meetings and other official government functions until she chose to abscond duty on or about 14th September,2023 to date.

iii. Encouraging and condoning insubordination/disrespect

20. This is not true. I am not aware of any particular instance. In any event, this is an HR issue which the DG ought to process within the required parameters.

iv. One Old Vehicle

- 21. Most departments have no vehicles, she is lucky to have one.
- 22. I am equally using an old vehicle that was being used by my predecessor.

v. Imprest/DSA/Per diem

23. This is not true. Her office is allocated Kshs.100,000 per month.

vi. Nepotism in Employment

24. This is not true. No evidence has been led on this score.

vii. Governor usurped roles of the CPSB e.g., in recruitment of kazi mtaani staff.

25. This is not true. No evidence has been led. Malicious complaint.

viii. Seeds project

26. This is not true. This was an open national tender which was processed lawfully and there no challenge to the same either at the PPARB or in any Court of Law.

ix. Demolitions

27. This is not true. Clearly, the DG has become a mouth piece for land cartels. In any case, these are matters active in court, therefore we are barred by the *sub judice* rule to discuss them.

D. Communications breakdown

28. I have been in constant communication with the DG until around 14th September,2023 when she deserted duty to date.

E. Ethnic Profiling and Incitement

- 29. This is not true. This a figment of her own imagination. Transzoia County remains a very peaceful County that draws its strength in diversity of the communities living there.
- 30. For your information, Transzoia County is among the 13 Counties in the Country that have complied with ethnic inclusion as required by the Constitution of Kenya.
- 31. Further, I was recently issued with an award by NCIC for my exemplary efforts as Governor in promoting peaceful co-existence of communities (Ethnic and Diversity Audit Compliance Award), it cannot therefore be true that I am profiling any community and/or causing incitement in whatever form or shape.

F. Conclusion

32. Honourable Members, as I have demonstrated the DG's complaints have no bearing at all. The prayers she has sought do not even fall within the purview of this House. Matters concerning security are not to be taken lightly and must be processed within the known channels. On disciplinary matters of employees, they must be processed within the established framework of dispute resolution in strict compliance with the rules of natural justice as prescribed by our laws. Further to this, it has come out very clearly that the DG is pursuing a matter of self-aggrandizement and there is nothing, even remotely to suggest that this is a public interest matter.

33. I beseech this House, to evaluate the threshold of complaints before it, it would serve justice, if certain complaints such as these are screened and extinguished even before summoning witnesses before it because by our very appearance here today, it serves a selfish interest purpose in favor of the DG who knows that our appearance alone no matter the outcome satisfies her goals.

That is what I wish to say.

Introduction

The National Cohesion and Integration Commission is a statutory body established by the National Cohesion Integration Act, No 12 of 2008. The Commission was formed under Agenda Item 4 of the Kenya National Dialogue and Reconciliation Accord, which focused on Longer Term Issues and Solutions key among them consolidating national unity. The object and purpose for which the Commission is established, is to facilitate and promote equality of opportunity, good relations, harmony and peaceful coexistence between persons of different ethnic and racial communities of Kenya, and to advise the Government on all aspects thereof.

Background information

H.E. Philomena Bineah Kapkory, the Deputy Governor Trans Nzoia reported to the National Cohesion and Integration Commission (NCIC) about the threats she is undergoing in line of her duty as the Deputy Governor of Trans Nzoia. In her statement, she claimed that her trouble began when the Sabaot Community began the petitioning for a County of their own.

The meeting by leaders and elders from Sabaot was to discuss matter touching on the proposed creation of a county for members of the Sabaot community.

However, H.E Philomena in her complaints alleges that the Governor of Trans Nzoia County H.E. George Natembeya is opposed to the creation of a county for Saboats, and is on record stating that the Sabaots were dreaming and they will not get any

county despite their petition to the National Dialogue Committee, requesting for the creation of County for Sabaots.

H.E. Philemon further reported that on the 23rd August, 2023, H.E the Governor stated that the Sabaot should be satisfied with the positions that they have in the County of Trans Nzoia and should stop asking for their own county. He further went on to state that not even an inch of Trans Nzoia would be hived off to form another county, insinuating that the Sabaot are greedy.

The above statement has led to the frequent attacks on the person to H.E the Deputy Governor Trans Nzoia on Social media. The social media platforms where the attacks and hate messages directed to the Deputy Governor Include:

- 1. Bunge la Wananchi
- 2. Obuntu Group
- 3. Endebess Development Forum
- 4. County of Trans Nzoia and
- 5. Facebook

ACTION TAKEN BY THE COMMISSION

The Commission is investigating the Governor of Trans Nzoia County H.E. George Natembeya, for the offence Ethnic Contempt Contrary to Sec 62(1) of NCIC Act and Hate Speech Contrary to Section 13(1) of The NCI Act No. 12 of 2008.

SEQUENCE OF EVENTS

1. 3RD OCTOBER, 2023

- i. NCIC received initial complain by HE. Philomena Bineah Kapkory the Deputy Governor of Trans-Nzoia County about the inflammatory utterances made by H.E. George Natembeya that was going viral on several social media platforms.
- ii. In regards to her complaint an Inquiry, File No. NCIC/COMP/13/2023 opened.
- iii. **H. E.** Hon Philomena Bineah Kapkory recorded her statement at NCIC commission offices.
- iv. The investigators travelled to Trans Nzoia County for the purpose for conducting investigations in regards of the complaint made by the deputy Governor.
- v. Request Letter was written the Communication Authority of Kenya (CAK) vide Ref. CID/IB/NCIC/SECPOL/4/4/VOL.11/108 requesting for the retrieval of Hon George Natembeya utterances clips.
- vi. The investigators travelled to Transnzoia County in order to serve HE Hon. George Natembeya the Governor of Transnzoia County the summons vide NCIC/comp/13/2023; the Governor personally received

and booked to appear at the NCIC Commission on 28th November, 2023 at 10.00am.

- 2. The matter has gone viral on social media platforms including WhatsApp group amongst other forums of Trans Nzoia, Bunge la Wananchi, Ubuntu group, Entebbe's development forum and COTN county of Transnzoia that could easily lead to ethnic discrimination amongst the Sabaots and other communities living in the County.
- **3.** This happened when the Sabaots demanded for a County of which the Governor reacted vehemently admonishing the Sabot community for their quest.
- **4.** It is alleged by members of the Sabaots that they have been discriminated during the employment, and that most of the employment opportunities are given to the dominant communities.
- **5.** Further findings and recommendations will be submitted after H. E. Governor George Natembeya appears before the Commission in order to assist with the ongoing investigations.

MEETING WITH THE STANDING COMMITTEE ON DEVOLUTION AND INTERGOVERNMENTAL RELATIONS ON SECURITY CONCERNS RAISED BY HON. PHILOMENAH KAPKORY, DEPUTY GOVERNOR, TRANS NZOIA COUNTY

Honourable Chair, this Committee has extended an invitation to me as the Cabinet Secretary for Interior and National Administration regarding security concerns raised by Honourable Philomenah Kapkory, the Deputy Governor for Trans Nzoia County.

I state as follows:

Honourable Chair, through a letter referenced F10357N/HSS/B dated 17th October, 2023, the Federation of Women Lawyers - Kenya wrote to the Director, Directorate of Criminal Investigations requesting for investigations into the security concerns raised by the Honourable Philomenah Kapkory, the Deputy Governor for Trans Nzoia County.

From their complaint letter, it was established that the Federation was acting on behalf of their client, Honourable Philomena. The complainant alleged that she has been threatened by people well known to her and that the perpetrators had published false information through various social media platforms, such as WhatsApp and messaging platform, among others.

To establish the veracity of the complaint, the investigating team contacted the complainant and she availed herself at the DCI Headquarters for interview and statement recording. From the interview, the complainant disclosed that she had already reported the matter at the office of the National Cohesion and Integration Commission (NCIC) in Nairobi and the Commission was handling the matter.

To this end, the investigating team has accomplished the following: -

- i. On 23rd October, 2023, the investigating team wrote to Communications Authority of Kenya vide DCI/IB/SCU/SEC/1/1/20A/VOL.V/20 in relation to the stated accounts for purposes of preservation and forensic analysis.
- ii. On 7th November, 2023, the investigating team wrote to National Registration Bureau vide DCI/IB/SCU/SEC/2/1/6/VOL.V/158 requesting for information in respect to the identity of suspects.

The Investigating team were able to get feedback from the National Registration Bureau and were provided with details of a blogger who was suspected of publishing the offensive posts on social meadia. He was traced, interrogated and his statement recorded.

On 21st December, 2023, the complainant was requested to submit her mobile hand set to facilitate forensic investigations. However, she is yet to do so.

The investigating team is yet to receive feedback from the Communications Authority of Kenya in order to commence the next course of action.
