CHAIRPERSON'S FOREWORD

The report documents the participation of a delegation from the Committee in the Mobile Consular Service (MCS) Exercise in Japan from 20th to 27th November, 2023. The aim of the participation in the activity was to assess how the MCS Exercise was being conducted and the challenges faced that would inform recommendations for future improvements.

Participation in the MCS Exercise was as follows: Wednesday, 22nd November, 2023 the exercise happened in Tokyo at the Kenya Embassy, Chancery; and Thursday, 23rd November, 2023 in Osaka at the Osaka International Convention Center (Grand Cube Osaka). The consular services availed for the Kenyan Diaspora Community in Japan were: Passport application and renewals; National I.D registration; Document Attestation; Birth Certificate Registration; and Regaining of Kenyan Citizenship.

Having participated in the MCS Exercise in Tokyo and Osaka and thereafter a courtesy visit to the Embassy, the delegation made the following recommendations:

- 1) The State Department for Diaspora Affairs should ensure budgeting and funding for MCS activities is always finalized before the execution of an activity to avoid facilitation challenges.
- 2) The National Treasury should:
 - a) Resolve the payment limitations on the E-Citizen platform regarding ability to use debit and credit cards.
 - b) Ensure a prompt and responsive 24-hour customer service support for the E-Citizen platform.
 - c) Revamp/upgrade the e-citizen platform in order to enable it to handle the load of services it is meant to handle.
- 3) Live fingerprint capture for Identity Card applications needs to be accelerated by the National Registration Bureau. This will greatly speed up data capture and enhance accuracy thereby reducing rejections.

Pursuant to Standing Order (S.O) 199(6), it is my pleasant duty to present to the House the Report of the Departmental Committee on Defence, Intelligence and Foreign Relations on its participation in the MCS Exercise in Tokyo and Osaka, Japan from 22nd to 24th November 2023.

1.0 PREFACE

1.1 Introduction

1. This report documents participation by a delegation of the Departmental Committee on Defence, Intelligence and Foreign Relations in the Mobile Consular Service (MCS) Activity in Japan (Tokyo and Osaka) from 20th-27th November, 2023.
2. The participation in the MCS Activity provided not only an opportunity for the Committee to carry out its oversight mandate on the utilization of the resources allocated to the State Department for Diaspora Affairs but also an opportunity to understand the challenges faced during the activity. This would inform the recommendations that will be proposed for future improvements.

1.2 Mandate of the Committee

3. The Departmental Committee on Defence, Intelligence and Foreign Relations is one of the twenty (20) Departmental Committees of the National Assembly established under *Standing Order 216*. The functions and mandate of the Committee include, among others, to:
 - a) investigate, inquire into, and report on all matters relating to the mandate, management, activities, administration, operations and estimates of the assigned Ministries and departments;
 - b) study the programme and policy objectives of Ministries and departments and the effectiveness of the implementation;
 - c) on a quarterly basis, monitor and report on the implementation of the national budget in respect of its mandate;
 - d) study, assess and analyze the relative success of the Ministries and departments as measured by the results obtained as compared with their stated objectives;
 - e) investigate and inquire into all matters relating to the assigned Ministries and departments as they may deem necessary, and as may be referred to them by the House;
4. The Second Schedule to the National Assembly Standing Orders assigns the Departmental Committee on Defence, Intelligence and Foreign Relations the mandate to consider matters in related to *Defence, intelligence, foreign relations, diplomatic and consular services, international boundaries including territorial waters, international relations, and veteran affairs*.

In executing its mandate, the Committee oversight the following MDAs: the Ministry of Defence (MoD), the State Department for Foreign Affairs (SDFa), the State Department for Diaspora Affairs (SDDA), the State Department for East African Community (SDEAC) and the National Intelligence Service (NIS)

2.0 MOBILE CONSULAR SERVICES-JAPAN (TOKYO AND OSAKA)

2.1 Background Information

9. Access to Government Services is a Constitutional right to every Kenyan citizen. For the Kenyan Diaspora due to the distance of their diverse locations, at times it has been a challenge for them to have access to critical government services like documentation (National Identity Cards and Passports). National Identity Cards are majorly needed by second-generation immigrants who are 18 years old and above while Passports are majorly required by first-generation immigrants, as well as undocumented Kenyans, who need to replace their prior passports.
10. In the past, the Government has provided these services through the missions with varying levels of success. Despite the past attempts the demand for government services by the Kenyan Diaspora has not been adequately met due to challenge of access to the central registry and technological lags in the e-citizen platform occasioned by time differences. It is on this basis that the State Department for Diaspora Affairs (SDDA) initiated a program to provide Mobile Consular Services (MCS) to the Kenyan Diaspora, as per a Presidential Directive issued by President Hon. Dr. William Ruto in December 2022. This directive mandates the relevant Ministries responsible for managing the Kenyan Diaspora to address their needs, acknowledging their significance to the Kenyan economy.
11. The SDDA has in place Mobile Consular Units (MCUs) that work closely with the State Department for Immigration and Citizen Services in taking the needed services to the Kenyan Diaspora.
12. The services offered to the Diaspora during the Mobile consular services (MCS) include: Identity card (ID) application and replacement; Passport application, renewal and replacement; Birth certificate application and replacement; Certificate of Good Conduct application; Marriage Certificate application; Document Attestation; Declaration of Dual Citizenship; Police Clearance Certificate; and Emergency Travel Certificate.
13. Since the inception of the MSC Activity, the SDDA has had two phases for the activity:
- (i) **Phase 1 (January -July 2023)**-Covered eight (8) Countries (New Zealand, Australia, United Kingdom, Qatar, Brazil, Oman, Canada and United States of America). In this phase a total of 5,549 Kenyans were attended to as summarized in table 1.

(ii) **Phase II (July-December 2023)**-Covered fifteen (15) countries namely Philippines, Singapore, Malaysia, Indonesia, Vietnam, Cambodia, Laos, Thailand, Saudi Arabia, France, Germany, Belgium, Japan, United States and South Korea. At the time of writing this report, the SDDA had not published the numbers. That notwithstanding, the Committee had an opportunity to conduct an oversight visit for the MCS Activities was for the Tokyo and Osaka cities in Japan. In addition, information of the MSC services offered in South Korea was shared and a summary of the number of services offered in Japan and South Korea is summarized in table 2.

2.2 Mobile Consular Service Activity Japan (Tokyo and Osaka)

2.2.1 Tokyo (22nd November, 2023)

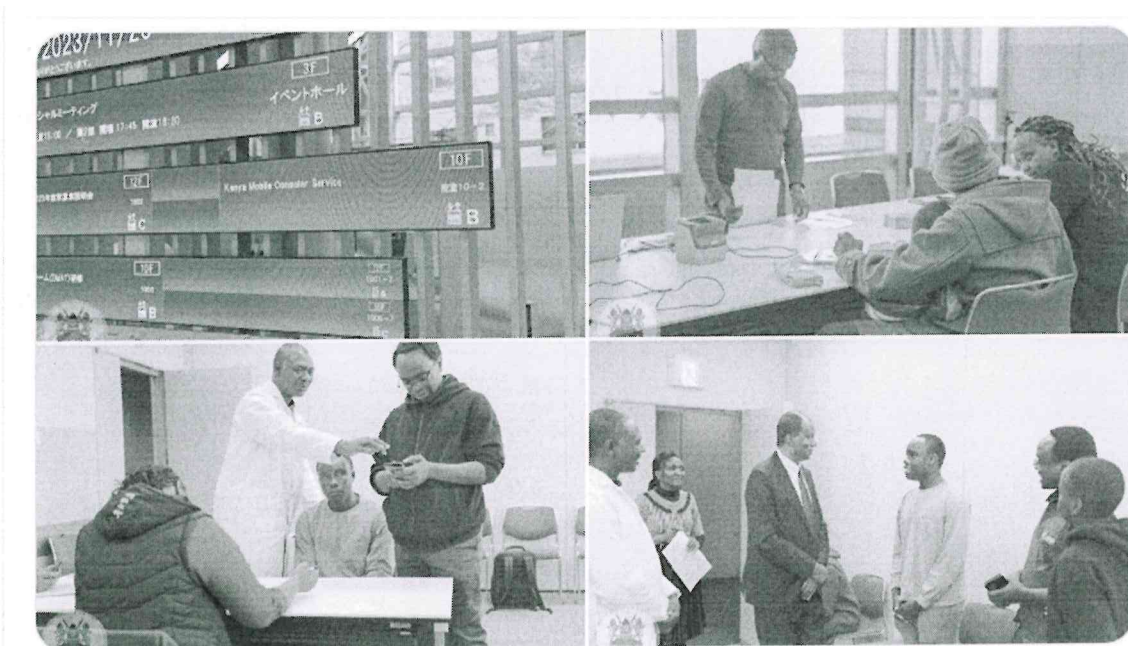
14. From table 2, a total of 13 services were offered in Tokyo which included only issuance of identification cards. This Activity took place at the Kenyan Embassy offices in Tokyo as shown below:

2.2.2 Osaka (23rd November, 2023)

15. From table 2, a total of 8 services were offered in Osaka which included: (i) 6 IDs; and (ii) 2 passport application/renewal. This Activity took place at the at the Osaka International Convention Center (Grand Cube Osaka) Room 1010-2, 10th floor as shown below:

2.2.3 Challenges During MCS Activity in Japan (Tokyo and Osaka)

16. The challenges encountered included:

1) E-Citizen related challenges:

(i) System is not Diaspora-friendly: Requiring local Kenyan addresses i.e., estate and village.

(ii) Challenge in uploading documents to the E-Citizen system.

(iii) System not credit/debit cards friendly: This forced the diaspora to wait for the people back home to start their day and request them to pay via MPESA because the system declined most credit/debit cards.

(iv) Non response from the official email support@ecitizen.go.ke i.e., it was rarely answered. Moreover, due to the time difference between Kenya and Japan, the officers providing the services were forced to wait for their Kenyan counterparts to get to the office, for the issue at hand to be handled.

(v) Due to a lot of services being loaded onto the system, it would be non-responsive for some minutes which really delayed the process of application and upload of the required documentation.

2) Budgetary constraints: Lack of adequate budgetary provision to facilitate the officers in the field (per diems, supplies, transportation, postage, etc.). Some of the officers in the field, were not facilitated hence were forced to use their own money or get support from the colleagues that were facilitated.

3) The tight schedule for the activity with no rest day(s) resulted in fatigue among the staff in the field.

4) Use of outdated technique in fingerprint capture: The National Registration Bureau still uses the manual ink-rolled fingerprint capture for ID applications which is an outdated way of capturing fingerprints.

4.0 OBSERVATIONS


17. The delegation observed the following:

- 1) There was adequate publicity of the exercise through the State Department of Diaspora Affairs, Embassy of Kenya in Japan, and Diaspora Community organizations.
- 2) There was low turnout in Tokyo than expected. This was attributed to the rescheduling of the MSC activity that was to happen in an earlier date (which happened to be a holiday in Japan). The designated date found most of the people at work and it was difficult for them to get time out to attend to the exercise.
